The quotations will be opened in the office chamber of the Child Development project Officer, Bhawanipatna(Urban) in presence of the Tenderers or their authorised agents on dated ~~21.01.2023~~ 20.23 at 3 P.M. The highest offer at or above the minimum price shall be approved by the District Social welfare Officer, Kalahandi then and there. The highest Tenderer shall deposit 25 % of the bid amount immediately after announcement and the rest within 7 days of the approval of the offer before the District Social Welfare Officer, Kalahandi.

The bidder will receive the vehicle from the Office garage of the CDPO, Bhawanipatna(Urban) within 7days from the date of deposit the full amount of the tendered/negotiated money. Custody or safe guard of the Vehicle shall be responsibility of the tenderer/ party and to claim or complaint on that account shall be not admissible.

Relevant documents alongwith the vehicle may be inspected in any working day from 10.00 A.M. to 5.00 P.M on prior appointment with the CDPO , Bhawanipatna(Urban).

On failure to make payment as aforesaid the deposits (including earnest money) shall be forfeited and the Vehicle put to fresh tender as the case may be.

The Vehicle shall not be delivered to the Tenderers/ party until after full payment and compliance with requisite formalities. Tools, implements and spare parts shall not be delivered with the Vehicle.

On failure to remove the vehicle within the time as foresaid, ground rent of the rate of one percent of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site

Where the ground rent so charged exceeds the sale price deposited, the tendered/party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.

The authority reserves the right not to accept, reject and cancel the tenders without assigning any reasons thereof.
