Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.

After the date and time of receipt of Bid is over, **the original bid security and Demand draft towards cost of Bid documents shall be submitted in the office of the undersigned in the specified tender box on or before date & time of opening of Bid** as specified at Para 08 above, during office hours on working days failing which the bid will be rejected.




