

TERMS & CONDITIONS FOR RE-EMPLOYMENT OF RETIRED ASSISTANT EXECUTIVE ENGINEER/ ASSISTANT ENGINEER/JUNIOR ENGINEER (CIVIL).

1. The re-employment shall be made initially for a period of one year subject to satisfactory performance and can be renewed basing on the good performance.
2. The re-employment shall be terminated at any time for dissatisfactory performance by PR & DW Department on notice of one month. In case of any misconduct including misappropriation, fraud, disobedience of order, negligence in duty or causing loss to Government, the service may be terminated without any prior notice.
3. Besides, the condition, mentioned in such Paragraph (02) above, the re-employed officers shall also be liable to proceeded against under the provision of Odisha Govt. Servant conduct rule and service code for any act of misconduct during the course of discharge of his duties during re-employment.
4. General instruction of Government regarding terms and conditions for re-employment as issued from time to time by GA Department shall be applicable and binding of the officers.
5. In case , the officer desires to resign from the engagement he may do so by giving a notice of one month in writing to the Joint Secretary to Government /Principal Secretary to Government , PR & DW Department , Odisha, Bhubaneswar under intimation to the controlling officer. After expiry of the notice period the officer may be relived after handing over the full and detail charges of the records and cash/Bank Accounts to the reliving officer as decided by PR & DW Department.
6. The re-employment officer shall be subject to and shall abide by the Odisha Govt. Servant Conduct Rules applicable to the Government Servant.
7. The tern and conditions are subject to codal provisions/memorandum/resolution issued by the Finance Department, Odisha from time to time.
8. The re- employment officers are entrusted with the powers and responsibilities as indicated at Para- 2.2.62, 2.2.64, 2.2.65 and 2.2.66 of OPWD Code Vol- 1.
9. During the period of contract the officers may be accompanied with Government quarters, subject to availability, provided he will pay the normal rent as applicable to a government Servant, occupying the Government accommodation.
10. The period of such engagement shall not be counted to Govt. Service for the purpose of pension or any other retirement benefits.
11. The payment of salary /monthly remuneration to the retired AEE/AE/JE (Civil) engaged on contract basis may be met out under NRuM Scheme
12. During the time of joining, the officers will submit a affidavit that no departmental proceeding or criminal case is pending against him. The affidavit will mention the present address, permanent address, date of retirement and post held during the time of retirement.
13. He will join in the new place of posting within a period of 15 days from the date of issue of order by the PR & DW Department, Odisha.
