Madam/Sir,

As you are aware Government of Odisha has imposed lockdown in the entire State with effect from 05.00 AM of 05<sup>th</sup> May, 2021 till 19<sup>th</sup> May, 2021. During the lockdown, several activities have been prohibited. Few activities are allowed in the interest of economic growth and livelihoods of people. Some of the activities which are allowed even during weekend shutdown are - industries in both rural and urban area, all agricultural related activities including production, transportation, marketing and trading of agriculture produce and activities ancillary to agriculture, such as trading and selling of chemicals and pesticides, fertilizers, agriculture tools and machineries, fish-feed, dairy, plantation activities, all construction activities in both Government and private sector and associated vehicles and manpower etc. Further, shops dealing with grocery items, fruits and vegetables, fish, meat, egg etc. will also be remaining open between 06.00 AM and 12.00 Noon on the week days. All the activities require regular monitoring by

the Department concerned to ensure that such activities are not hampered anywhere in the State. Further, the supply lines dealing with food and essential commodities need to remain open. Concerned Departments are, therefore, requested to ensure that their offices are kept open during the lockdown period so as to ensure support for all permitted activities to continue unabated. Arrangements made in this behalf may kindly be intimated to the Office of Special Relief Commissioner, Odisha for information.
