In partial modification of the Government of Odisha in Revenue & DM (Disaster Management) Department order No.7458/R&DM(DM) dated 24.12.2021, the State Government do hereby make the **following modification** to the said order, namely:-

In paragraph- 3 "restrictions from 25<sup>th</sup> December, 2021 till 2<sup>nd</sup> January, 2022" may be read as "restrictions on 25<sup>th</sup> December, 2021 and 31<sup>st</sup> December, 2021 to 2<sup>nd</sup> January, 2022."
