Sub: Strict vigilance on crowd and gatherings in public places.

Ref: Order No.7458/ R &DM(DM) dated 24.12.2021

Sir,

Keeping in mind the possible crowd and gatherings at public places on 31<sup>st</sup> December, 2021, 1<sup>st</sup> & 2<sup>nd</sup> January, 2022, Government has already imposed restrictions vide order under reference for containment of COVID-19.

It is again reiterated that following actions may be taken on these days in exercise of powers conferred U/s 2 of Epidemic Disease Act, 1897, Disaster Management Act, 2005 and Odisha COVID-19 Regulation, 2020.

- (i) Random checking of crowd & gatherings at public places such as picnic spots/ malls/ shopping complexes/ hotels/ clubs/ restaurants/ parks/ convention halls/ kalyan mandaps etc.
- (ii) Strict enforcement of COVID-19 safety protocols such as wearing of masks, maintaining social distancing of at least six (6) feet between persons at public places.
- (iii) Impose any additional restrictions as may be felt necessary in the interest of containment of the spread of COVID-19
- (iv) In case of violation of COVID-19 protocols, heavy penalty may be imposed as decided by the Local Authorities.
