## **ORDER**

## Addendum to Order No.280/R&DM (DM) dated 12.01.2022 & No.347/R&DM(DM) dated 15.01.2022

Whereas, the Government of Odisha in Revenue & Disaster Management (Disaster Management) vide its Order No.280/R&DM(DM) dt.12.01.2022 & No.347/ R&DM (DM) dated 15.01.2022 have prescribed regarding stipulations on large gatherings/ congregations, permission of Political gatherings/ meetings, rallies for General Elections to PRIs,2022.

And whereas, the State Election Commission vide their Order no. 2062/SEC dated 7<sup>th</sup> February, 2022 has partially relaxed the restrictions imposed vide their letter No.225/SEC dated 10.01.2022 so far as physically rally/ meetings are concerned in the context of conducting General Elections to PRIs, 2022.

Now, therefore, as per the COVID guidelines issued by State Election Commission vide their Order no. 2062/SEC dated 7<sup>th</sup> February,2022 & in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules,2010, the State Government, in supersession of Order No.280/R&DM(DM) dt.12.01.2022 & No.347/R&DM(DM) dated 15.01.2022, do hereby lay down the following stipulations in the State of Odisha for physically rally/ meetings for General Elections to PRIs,2022 with effect from 07.02.2022.

- Door to door campaign with 20 (twenty) persons, including the candidate, is allowed instead of 5 (five).
- Public meetings can be organised by the Political Parties/ Contesting
   Candidates with prior permission of the appropriate authority with

maximum 300 (three hundred) persons in open ground subject to strict observance of Covid-19 protocols i.e. compulsory use of face mask and social distancing.
