**ORDER**

Whereas, the Government of Odisha vide Order No. 707 dated 31.1.2022 have prescribed COVID guidelines/ instructions/ permissions of activities / stipulations for containment of COVID-19 till 5.00 AM of 28<sup>th</sup> February, 2022 and imposed Night Curfew in all urban areas of the State from 10.00 PM to 5.00 AM every day;

Whereas, a continuous decrease in the number of COVID cases is observed in the State and number of active cases has also decreased.

Now, therefore, in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules, 2010, **the State Government do hereby order that**

**"Night Curfew is withdrawn/ lifted from all urban areas of the State with effect from 18<sup>th</sup> February, 2022".**

In case of any other doubt, the State Government in Revenue & Disaster Management (Disaster Management) Department will issue necessary directions or clarifications.


