2. The supplier should have upto date GST Registration Certificate. (Photo copy of GST registration certificate should be submitted)
3. He/she should have PAN card No. (Photo copy of PAN card should be submitted)
4. Rates should be quoted inclusive of charges of GST/transportation and other taxes as applicable.
5. The District Administration will have no liability regarding transportation, loading and unloading of materials and all the materials ordered for shall be delivered at the designated place in good condition.
6. The tenderer should deposit EMD of Rs.2000/- (Rupees two thousand) only in shape of Demand Draft in favour of "Collector, Kalahandi" payable at SBI, Main Branch, Bhawanipatna. Tenders without EMD Money will be liable for rejection.
7. The EMD money deposited by the successful tenderer will stand converted to security deposit, which will be refunded after successful of completion of supply. The EMD of unsuccessful tenderers shall be refunded after finalization of the tender process.
