





The sealed envelope should be super scribed with "**Tender for Crop Residue Enrichment Programme**". The items will be delivered at office of the Chief District Veterinary Officer, Kalahandi. The tenderer may quote the price bid for any or all the inputs required for the purpose. An EMD of Rs. 10,000/- or 2 % of the total cost of input materials should be attached with the bid in shape of Bank Draft of any nationalized bank payable to Chief District Veterinary Officer, Kalahandi and the same will be returned to the unsuccessful bidders or will be added with the final payment of the successful bidder on supply of the requisite quality and quantity of the items. The absence of tenderer or his representative will not be a bar to open the tender. 

**TERMS OF REFERENCE**


1. The last date of submission of Tender is **17.02.2023 by 05:00 PM** and the same will be opened on **21.02.2023 at 10:30 AM** in the office chamber of the Chief District Veterinary Officer, Kalahandi.
2. The manufacturers/ Stockiest/ Authorised dealers/ Govt. approved firms can participate in the tender process for any of the items or all items of the inputs.
3. Bidders need to have experience for 3 years in supplying of the above inputs. In support of experience' the bidder has to submit experience certificate or copy of the bills of the products supplied along with documents submitted for technical bid.
4. Annual turn over:- The bidder should have audited annual average turn over of 10 lakh per year for the last 3 years i.e. during 2019-20, 2020-21 & 2021-22.
5. The intending bidder will have to submit up to date income-tax return and should have up to date GST Return.
6. Preference may be given to the supplier/ agency that can provide all required inputs or as per the decision of the tender opening committee.
7. The tender will be valid for one year from the date of finalisation.
8. The bidder or their authorised representatives shall be present at the time of opening of the tender.
9. The interested Agencies / Firms may take the tender documents from the office of the Chief District Veterinary Officer, Kalahandi during the office hours in any working day or can download the document from Kalahandi District web portal: (<http://kalahandi.nic.in>).
10. The Chief District Veterinary officer, Kalahandi reserves the rights to reject the lowest bid quoted by the Agency/Firm, if not satisfied with the concerned Agency/Firm's credibility and put to experience or if the qualities of the sample items are not satisfactory.
11. Further the Chief District Veterinary Officer, Kalahandi also reserves the rights to accept/reject/modify any or all the bids without assigning the reason thereof.
12. An EMD of Rs.10,000/- or 2% of the total cost of input materials should be attached with the bid in shape of Bank Draft of any nationalized bank payable to Chief District Veterinary Officer, Kalahandi and the same will be returned to the unsuccessful bidders or will be added with the final payment of the successful bidder on supply of the requisite quality and quantity of the items.
13. No communication shall be entertained over telephone, FAX and E mail or in person.
14. Any legal dispute shall be finalized in Bhawanipatna jurisdiction only.






