The Sealed quotation in plain paper/Letter pad are invited from intending firms/agencies for installing Mina Bazaar for a period of 6 days i.e; from 15.01.2023 to 22-01.2023 within the area of the Revenue Colony premises specified for entertainment of the public on the occasion of celebration of Kalahandi Utsav, GHUMURA- 2023 . The quotation should reach the undersigned on or before 02.01.2023 by 1.00 PM. The sealed quotations will be opened on the same day at 3.30 PM by the committee in presence of the Proprietor of the concerned Firms/ Agencies or their authorized representatives. The proprietor of the firm/ agency whose quoted amount is the highest will be selected as the highest bidder and he/she will be invited to install the "Mina Bazaar" at the specified venue meant for the purpose.

**The terms and conditions of the quotation are indicated below.**

1. The rate shall be submitted in sealed cover wherein the quoted amount shall be mentioned both in digits and words.
2. The quotations received incomplete or after the scheduled date and time shall be rejected.
3. The selected bidder to deposit 75% of the quoted amount in terms of cash / RTGS/ NEFT and. the balance 25% of the quoted amount shall be deposited in favour of the Kalahandi Utsav Committee, Dharamgarh in terms of Bank Guarantee / Demand Draft / Cheque by 5.00 PM prior to the date of installation
4. The Kalahandi Utsav Committee, Dharamgarh reserves the right to cancel or reject all or any quotations without assigning any reason thereof.
5. The proprietor/ Agency shall have to take necessary measures for crowd management along with safety and security of the visitors.
6. The proprietor/ Agency shall abide to all the laws/rules meant for installation of such establishment and shall take necessary permission from competent authority for the required purpose prior to opening of the fair.
7. The proprietor/ Agency shall be held responsible if any untoward incident occurs due to his negligence.
