



## TERMS AND CONDITIONS FOR SUPPLY OF VETERINARY MEDICINE UNDER CDVO, KALAHANDI FOR A PERIOD OF ONE YEAR.

1. The bidders will download the tender from the District Web Site: [www.kalahandi.nic.in](http://www.kalahandi.nic.in) by Tender cost of Rs.2000/- (Rupees Two thousand only) and EMD Cost. Rs.20,000/- (Rupees Twenty Thousand) in shape of Demand Draft in favour of the CDVO, Kalahandi.
2. The tender paper will be rejected if the bidder changes any clause or Annexure of the bid documents downloaded from the website.
3. Sealed tenders will be received by date 13.04.2023 up to 05:00 PM by the CDVO, Kalahandi in the office of the CDVO, Kalahandi for the purchase of Veterinary Medicines. Any tender paper received after the due date and time will be rejected. The tender paper will be received through Speed Post/ Regd. Post Only. The Sealed tenders will be opened on dated 17.04.2023 at 03.30pm.
4. The CDVO shall have no responsibility for any delay / Omission on part of the bidder and reserves the right to reject any or all the tenders without assigning any reason thereof.
5. The bidder(s) are to submit their tenders in separate sealed covered envelop with Price Bid & superscripting Cover as "Tender for Supply of Veterinary Medicines for Infertility camps 2022-23" and Tender Reference No. 1455/ CDVO(KLD) Dt. 06.04.2023
6. The sealed tenders will be opened by the Committee formed by CDVO, Kalahandi in the office chamber of the CDVO, Kalahandi on Dated 17.04.2023 at 03.30 PM. The bidders or their duly authorized representatives are allowed to be present during the opening of the tenders if they so like but their absence will not be bar to open tenders.
7. The rate quoted by the bidder should be inclusive of all taxes (VAT/CST/ET/Freight/GST/ Insurance etc)
8. Conditional tenders are liable to be rejected .All Disputes are subjected to Hon'ble Court of Bhawanipatna, Kalahandi, Odisha jurisdiction.
9. Valid Wholesale / Distributor License from the Drug Controller be submitted with tender.
10. Tender will be submitted with Valid ISO Certificate and Authorization Certificate of the Product.
11. The bidder should have proof of supply 3 years supplying medicines to any Govt. organization / corporate hospitals / PSU / Govt. Hospital / Dispensary.
12. If the successful bidder/ bidders fail to supply within the stipulated period i.e. 15 (Fifteen) days from date of receipt of order from CDVO, Kalahandi liquidated damage @ 0.5% of the tender value per week of delay shall be deducted from the final payment. Maximum delay time acceptable is 1 week. Hence, the maximum liquidated damage shall be up to 0.5 % of purchase order. If the bidder fails to supply within the maximum delay time his order stands cancelled automatically.
13. The Authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.
14. Towards the testing of sample, the supplier will have to supply extra one quantity of medicines sample for each item of indent at his own cost for which no payment will be made by indenting officer.

15. The supply of items shall be made immediately according to volume after placing the supply order in the office of the CDVO, Kalahandi and supplier shall submit the bill for payment at the approved rate in respect to quantity of items supplied. The transportation of items is sole responsibility of the supplier and must deliver the item in the office address i.e. CDVO, Kalahandi, At/PO- Purunapada, Via-Bhawanipatna, Dist-Kalahandi, Pin-766001.

16. In case of failure on the part of the approved supplier to supply of the above mentioned items as per supply order with stipulated period, the CDVO, Kalahandi shall be at liberty to purchase above mentioned items from other sources and the approved supplier shall be liable to pay the excess amount which this office have to incur being the different of actual amount of purchase minus the amount as per approved rates and difference aforesaid shall be recoverable and adjustable against the security deposit amount.

17. Under no circumstances selected bidder will appoint any sub contractor or sublease the contract. If it is found that the organization has violated these conditions the contract will be terminated forthwith without any notice and security deposited by the organization shall be forfeited.

18. Rates quoted against this tender notice shall remain valid up to 12 months after award of contract. No request of increase in rates, if any, will be allowed or entertained during this period.

19. Bidders should submit the valid drug license photocopy (self attested).

20. Bidders should submit the photocopy of valid GST Clearance Certificate & PAN Card.

21. Receiving & Opening of Tender may be changed if required by the undersigned, which will be intimated.
