ORDER

An allotment of 17348.4 Quintals of Rice received vide Letter No.15936. dt.21.10.2022, from the Govt. Food Supplies & Consumer Welfare Department, Odisha for the 2nd half of 2022-23 i.e from October 2022 to March 2023 are to be distributed among the 19276 boarders of Welfare Institution & Hostel Scheme (Government Owned/Run) ST/SC & SME of Kalahandi District managed by ST & SC Development Deptt., Odisha. The scale of entitlement is limited to 15 Kg per boarder per month. The Rice should be lifted from RRC-cum-DSC of concerned Block by the concerned Head Master/Head Mistress of the institutions on payment of Rs.1/- per Kg., failing which this allotment shall be automatically cancelled. The entire quantity of the allotment will be provided by the OSCSC Ltd from the State Pool.

It is requested to issue fortified rice to the welfare institution/Hostels (Govt. Run/Own and Aided/Sponsored only) in this district wherever fortified rice has been made available.

- 1. There will be no diversion of rice from WI Scheme to ST/SC Hostel and vice versa.
- 2. The institutional Head is directed to deposit the cost well in advance and all other . terms and condition remain unchanged.
- 3. The institution should be given entitlement cards to enable them to lift rice. The District Level Officers concerned of Department will certify utilization of stock for bonafide purpose in the end of every month.
- 4. The institutions will lift quota from the concerned Rice Receiving Centre-cum-Departmental Storage Centre and they will not be asked to lift rice from F.C.I. /D.P.C. The Officer-in-Charge of RRC-cum-DSC will issue cash memo to the Institutions and obtain signature.
- 5. The allotted stock of rice to be lifted by the concerned institutes by the last day of the preceding month of the allocation month without fail in 28.02.2023.

6. The Utilization Certificate for the following allocation of Food Grain should be submitted to the undersigned by 5th of succeeding month for releasing of fresh consignment.
