Sealed quotation in plain paper addressed to the District Social Welfare Officer, Kalahandi accompanied with a Bank draft amounting to Rs.1000/- (Rupees one thousand) only drawn in main Branch S.B.I. Bhawanipatna in favour of District Social Welfare officer, Kalahandi payable at SBI, Bhawanipatna which shall be subject to refund immediately except in case of the highest offer accepted by the Committee . The last date of submission of tender is on 16.02.2023 at 3PM. The quotations will be opened in the office chamber of the District Social Welfare Office, Kalahandi in presence of the Tenderers or their authorized agents on dated 16.02.2023 at 3.00 P.M. The highest offer at or above the minimum price shall be approved by the District Social welfare Officer, Kalahandi then and there. The highest Tenderer shall deposit 25 % of the bid amount immediately after announcement and the rest 7 days of the approval of the offer with the District Social Welfare Officer, Kalahandi.

The bidders will receive the vehicle from the Office premises of the DSWO, Kalahandi within 7days from the date of deposit the full amount of the tendered/negotiated money otherwise the amount deposited shall be forfeited and the bidder will be seized to have any right on the auction sale. Custody or safe guard of the Vehicle shall be responsibility of the tenderer/ party and to claim or complaint on that account shall not be admissible.

On failure to make payment as aforesaid the deposits (including earnest money) shall be forfeited and the Vehicle put to fresh tender as the case may be.

The Vehicle shall not be delivered to the Tenderers/ party until after full payment and compliance with requisite formalities. Tools, implements and spare parts shall not be delivered with the Vehicle.

On failure to remove the vehicle within the time aforesaid, ground rent of the rate of one percent of the tendered/negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.

Where the ground rent so charged exceeds the sale price deposited, the tendered/party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Government free from all encumbrances and disposed off by fresh sealed tender as the case may be.

The authority reserves the right not to accept, reject and cancel the tender without assigning any reasons thereof.
