### QUOTATION / TENDER CALL NOTICE

Sealed quotations / tenders are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing 1(one) No. of hire vehicle (Tuv/ Bolero N10 or N8 BS-6 having sitting capacity not more than 07 including driver, which shall conform to the Terms and conditions (Annexure – II) for official use of the Regional Transport Officer, Kalahandi on monthly rent basis.

1. The vehicle must be in Road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date Tax payment etc. which are mandatory for plying of vehicle. The vehicle owner should also have valid GST Registration Number.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the Regional Transport Officer, Kalahandi payable at S.B.I, Main Branch Bhawanipatna and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charges to be quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 10 kms. Per liter.
7. The details of the make and year of manufacturer of the vehicle, registration no., mileage (kms covered per liter) and name of the Driver with Driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-III).

8. The Quotation completed in all respect should reach the undersigned by Regd. Post / Speed Post on or before 13.03.2023 by 1.00 P.M "Application for Tender for Hiring Vehicle" should be written on the top of the envelope addressed to the Regional Transport Officer, Kalahandi. The tender shall be opened on the same day at 4.00 p.m. in presence of the bidders or their authorized representatives in the office of the Regional Transport Officer, Kalahandi.
9. The application form of quotation / tender containing General Bid information & Terms and conditions for Hiring of Vehicles etc. will be available in the Office of the Regional Transport Officer, Kalahandi, Bhawanipatna on payment of Rs.100/- from 06.03.2023 to 13.03.2023 (12 Noon).
