

ORDER

A stock of **94.35 Quintals of Subsidized Rice** has been allotted vide Letter No.2049 dt.14.02.2023 from Managing Director, OSCSC Ltd, Bhubaneswar in favour of Govt. aided institutions and non Govt. aided private Child Cared Institution (CCIs) for the 3<sup>rd</sup> and 4<sup>th</sup> Quarter of 2022-23 i.e from Oct' 2022 to March 2023 for distribution prospectively, as per letter No. 17171, date.15.10.2022 of Department of Women & Child Development and Mission Shakti. It is to be distributed among the **4 nos of Non-Gia (private) CCI & 7 nos of Govt. Aided CCI** institution of Kalahandi respectively (list enclosed). The scale of entitlement is limited to 8.5 Kg per inmates per month. The Rice should be lifted from **RRC-cum-DSC** of Bhawanipatna & Dharmagarh Block by the concerned Gia & Non-Gia Child Care institutions on deposit of issue price @ Rs.6.30/- per Kg and Rs.9.30/-per Kg for Gia & non-Gia CCA respectively. The entire quantity of the allotment will be provided by the OSCSC Ltd from the State Pool.

1. There will be no diversion of rice from Women & Child Development and Mission Shakti Deptt.
2. The institutional Head is directed to deposit the cost well in advance and ensure lifting of allotted quantity of rice positively. All other terms and condition remain unchanged.
3. The institution should be given entitlement cards to enable them to draw rice. The District Level Officers concerned of Department will certify utilization of stock for bonafide purpose in the end of every month.
4. The institutions will lift quota from the concerned Rice Receiving Centre-cum-Departmental Storage Centre and they will not be asked to lift rice from F.C.I./D.P.C. Depots. The Officer-in-Charge of RRC-cum-DSC will issue cash memo to the Institutions and obtain signature.
5. Any excess quantity lifted by CCIs will be subject to deduction from next allotment months.
6. The Utilization Certificate for the following allocation of Food Grain should be submitted to the undersigned by 5<sup>th</sup> of succeeding quarter for releasing of fresh consignment.
