## QUOTATION CALL NOTICE

Sealed quotations are invited from interested reputed Travel Agencies/Tour Operators or private individual in the enclosed format for providing 1(one) A.C diesel driven TUV 300 vehicle having sitting capacity of not more than 10(Ten) including driver, which shall conform to the Terms and Conditions given below for official use in Koksara block on monthly rent basis for a period of 1 year. The maximum hire charge per month is Rs.31, 000/- as prescribed by the government.

1. The vehicle must be in road worthy condition and must not be more than 3 years old from the date of initial registration. It should have Valid Registration Certificate, Fitness Certificate, valid Condition Carriage Permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a Valid Driving License for driving light transport vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. The monthly rate of hire charge be quoted separately in the general information (excluding fuel and lubricant but including remuneration of the driver).
5. The Vehicle must achieve a fuel efficiency of 10 Kms. per litre.
6. The details of the make and year of manufacture of the vehicle, registration number, mileage (Kms. covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically be provided in the general bid information to be furnished with the quotation .
7. The quotation must be accompanied with copies of relevant documents and an Account Payee Bank Draft of Rs.5000/- (Rupees Five Thousand only) drawn in favour of Block Development Officer, Koksara payable at Koksara as Security Deposit. The Bank Draft of unsuccessful bidder will be returned whereas the Bank Draft of successful bidder will be retained which will be refunded after expiry of the period of contract. The quotation without copies of relevant documents and Bank Draft of specified amount will be summarily rejected.
7. The quotation complete in all respect should reach the undersigned on or before 16.07.2021 up to 4.00 P.M through registered post only. No other mode of submission of the quotation will be accepted. Quotations received after due date will not be accepted under any circumstances. The cover containing the quotation must be superscribed as "QUOTATION FOR VEHICLE". The quotations received within the due date shall be opened on the same day at 4.30 P.M in presence of the bidders or their authorized representatives who may like to present.
