TENDER CALL NOTICE

Sealed tender in the format mentioned below are hereby invited from the intending Firms/ Registered Suppliers/ Dealers for supply of **Goat** (Doe / Buck) for Mission Jevika at ITDA, Th.Rampur at Bhawanipatna in the district of Kalahandi, Odisha.

[A] Tender under two bid system:

The Tender has been invited under two bid system i.e. Technical Bid and Financial Bid. The intending Firm/Register Dealers must submit. Two separate sealed envelopes super scribing:

ENVELOPE NO.1: “**Technical Bid** for supply **Goat**.”

ENVELOPE NO.2: “**Financial Bid** for supply **Goat**.”

Both the afore stated bids be placed in a third envelope superscribed with :
“Tender Call Notice No..... Dt.....Tender for supply **Goat** .

[B] Documents to be attached:

Tender should be accompanied with the following:

[1] E.M.D. [**REFUNDABLE**] for 20,000/- (Rupees Twenty thousand) only in shape of Bank Draft to be drawn in favour of the “PROJECT ADMINISTRATOR, ITDA, TH.RAMPUR” drawn in any nationalized Bank, payable at Bhawanipatna [Immediately after finalization of the Tender the E.M.D. of the unsuccessful Quotationers will be refunded].

[2] Photocopy of GST clearance certificate,

[3] Photocopy of Income Tax clearance certificate

[4] Authorized Dealership Certificate

[5] List showing the Government Office/Institutions [Govt. of Odisha, Govt. of India, Other State Governments or State Government Agencies]/reputed Organizations in which previously supplied Goat have been made by the Firm if any be submitted alongwith the photocopy of orders for supply of the same received from the Institutions.

[6] Statement showing Annual Turn Over for the last three financial years immediately preceding the current financial year.

[7] Documents if any, issued by the competent authority exempting the Firm from submitting the EMD.

[8] Other relevant documents if any



[C] TECHNICAL SPECIFICATIONS:

1. Breeds: Black Bengal and or Ganjam variety
2. Age:
 - (i) Male (Buck) – Age Should be 15-18 month
 - (ii) Female (does) – Age should be 12-15 month
3. Body weight:
 - (i) Male (Buck) – should be 15 Kg (Minimum)
 - (ii) Female (Does) – should be 12 Kg (Minimum)
4. An authentic Certificate from a Registered Veterinary practitioner under jurisdiction of the State / Govt. of Odisha (having B.V. Sc. Or higher degree from a recognized university) on good health condition of goats be furnished alongwith goats. Any damage to or loss of animals before their supply to beneficiaries will be borne by the supplier.
5. It is responsibility of the supplier to bear transport cost and cost of keeping goats on quarantine for period of 21 (Twenty One) days and extra 02 (Two) days time for supply to beneficiaries.
6. The health check up and verification of age of goats will be done by an Expert Team consisting of Technical Officers & Officers from ITDA during last 03 days of housing on quarantine and only fit and healthy ones will be received. The rejected / sick goats will be replaces by healthy ones at cost of the bidders.
7. Total duration for supply of indented goats must be completed within 30 (Thirty) day from date of issue of order failing which the order is likely to be placed to 2nd lowest bidder and the EMD besides performance security (5% of total estimate amount to be deposited alongwith agreement before issue of order) of sleeved bidder will be forfeited.
8. Though 1st lowest bidder is to be preferred, this may be guided by other parameters as would be finalized by the Committee.

[E] Procedure for selection of lowest bidder:

(a) In the first instance the documents pertaining to the eligibility criteria of the Bidders shall be verified and eligibility to participate in the process be determined.

(b) The Envelope containing the Technical bid be opened to examine the qualitative aspects of the materials indented for procurement.

(c) The Financial bids to be submitted in the prescribed format of the approved Bidders shall then be opened and finalized.

[F] Duration for receipt of Tenders/Closing hours:

Sealed Tenders addressed to the "**PROJECT AMDINISTRATOR, ITDA, TH.RAMPUR AT/PO; BHAWANIPATNA, DISTRICT; KALAHANDI, ODISHA, PIN:766001**" should reach this office by Registered Post/Speed Post only on or before 4.00 P.M. on 04.12.2021 if this day is declared as holiday by Government the next working day shall be the last date for receipt of the Tenders.

[G] Opening of Tenders:

The Tenders will be opened on 06.12.2021 at 11.00 A.M. by the purchase Committee in the office chamber of the "PROJECT AMDINISTRATOR, ITDA, TH.RAMPUR" in presence of the Tenderers or their authorized representatives. If however the date of opening of the quotations i.e. 06.12.2021 is declared as holiday by Government the Tenders will be opened on the second working day after 06.12.2021 at the time and venue stated above.

[H] Validity of Rate Approved:

The rate approved shall remain valid during the period of one year commencing from the date of finalization of the Tender which will facilitate procurement of further systems during the said period.

[I] Security Deposits:

5% [five percent] of the payment value be the Security Deposit and be retained in this office for a period of one year from the date of first supply. In case of failure to supply in time or for any deficiency relating thereto the same shall be forfeited.

[J] Payment on supply & installation:

Payment *in respect of the system indented and supplied* shall be made by e-transfer for which the selected Firm should submit the Account No, Name of the Bank and the IFSC Code along with the Bill duly signed by him.

[K] Acceptance or Rejection of Tenders:

The undersigned reserves the right to accept or reject any or all quotations at any stage and may also increase or decrease the quantity indicated above without assigning any reason thereof.
