


1. The sealed tenders are invited from the intending manufacturers/ authorized dealers/ suppliers for procurement of Counting materials and Election materials for General Election to PRIs, 2022.
2. Tender papers required for the tender call can be obtained from the District Panchayat Office, Kalahandi on payment of Rs.1000/- (Rupees One thousand) only (non-refundable) in cash towards cost of Tender paper on any working day from the date of this notice till **10th December, 1.00 PM** during office hour.
3. The Tender papers can also be downloaded from the district website <http://www.kalahandi.nic.in>. In case of tender papers downloaded from the district website for using the tender call, it shall accompany Bank Draft of Rs.1000/- (Rupees One thousand) only in favor of "**District Panchayat Officer, Kalahandi**" payable at SBI Main Branch, Bhawanipatna.
4. The tender paper shall reach the District Panchayat Office, Kalahandi by Registered post/ Courier Service/ Speed post only on or before **10th December, 2021** at **1.00PM**. The tender received beyond the date and time mentioned above shall not be taken into consideration.
5. Tender papers must be accompanied with the money receipt/ DD towards cost of Tender papers and other relevant documents as mentioned in the tender paper. Failure to comply the instruction specified there on or non-submission of any of the documents specified, the bid shall summarily be rejected.
6. The sealed tenders will be opened on **10th December, 2021** at **5 PM** by the undersigned in this Office in presence of the tenderers or their authorized agents and members of the District level purchase Committee constituted for the purpose.



Tender Paper of the Tender Call Notice for Procurement of Counting Materials and Election Materials for General Election to PRIs 2022, Kalahandi

Terms and Conditions:

1. Sealed tenders are invited from intending suppliers, manufacturers and authorized dealers bearing GSTIN for supply of screens and ballot box covers for General Election to PRIs 2022, Kalahandi.
2. The tender will be in two parts i.e. Technical Bid (Part-I) and Financial Bid (Part-II). The Bidders should give their Technical and Financial Bids separately in two envelopes and should put into another Cover Superscribed as "**Tender for General Election to PRIs 2022**" for procurement of counting materials and Election materials.
4. The other terms and conditions associated with the assignments mentioned in **Annexure-A**.
5. The last date of submission of tender paper is **10th December**, at 1.00 PM.
6. Bidders who qualify technical bid, their financial bid shall only be opened.
7. The successful Bidder have to submit the delivery within **10 days** from the date of issue of indent order from the District Panchayat Office, Kalahandi.
All the materials will be submitted to Office of District Panchayat Office, Kalahandi.
9. The details of the Specification of the items required for supply of Counting materials and Election materials mentioned at **Annexure-B**.

Annexure-A
Terms and Conditions

1. For the supply of Counting materials and Election materials, supplying Agency should be bona-fide registered body having valid Registration No. for supplying the same.
2. The supplying agency should have PAN/ TIN & up to date GST clearance Certificate (**up to 30th June, 2011**)
3. It has not been blacklisted by any Government Organization.
4. Rates should be quoted **inclusive** of all charges of GST and other taxes as applicable including transportation.
5. The District Administration will have no liability regarding transportation, loading and unloading of materials and all the materials ordered shall be delivered at the designated place in good condition. The defective or damaged material if any will be replaced by the agency immediately.
6. The tenderer should deposit EMD of Rs.5000/- (Rupees Five Thousand) only in shape Demand draft in favour of District Panchayat Office, Kalahandi payable at SBI main Branch Bhawanipatna. The EMD will be refunded after successful completion of supply. EMD of unsuccessful tenderers shall be refunded after finalization of the tender process.
7. Self-attested certificate of MSME will be exempted from giving EMD.
8. Money receipt in original in support of purchase of tender papers or Demand Draft of Rs.1000/- (Rupees One Thousand) only payable at SBI Main Branch Bhawanipatna in favour of District Panchayat Office, Kalahandi is non-refundable in nature.
9. Conditional tender is liable to be rejected. In the event of acceptance, the Tender Committee's decision will be final. The tender, which is not as per our required specifications will not be considered.
10. If the successful bidder fails to supply within the stipulated period i.e.10 days of receipt of supply order, liquidated damaged @ 2 % per day of delay shall be deducted from the final payment.
11. The District Panchayat Office will not pay any advance payment to the successful bidder. The supplying Agency to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of the bill in that regard.
12. The payment will be made after receipt the bills from supplier. The tender committee will test the quality of supply.
13. Rates quoted against this tender shall remain valid up to 12 months after publication of approved rate. No request for increase in rates, if any, will be allowed or entertained during this period.
14. Tenderer requires to submit the sample items as per specification for test check.

15. Under no circumstances shall the supplying agency appoint any sub-contractor or sublease for the contract. If it is found that the supplying agency has violated such conditions then the contract will be terminated without any notice and EMD shall be forfeited.
16. The detailed tender paper should be submitted with the tender duly signed by the tenderer as a token of acceptance of the terms and conditions.
17. The Tender Committee reserves the right to accept or reject any or all the tenders without assigning any reasons whatsoever.
18. Income tax returns for last one financial year 2019-20 is mandatory.
20. Self-declaration is essential in connection with bidding by all terms and conditions in tender.
21. All documents are to be submitted with self-attestation.
