



SECTION-II

Instruction to Bidders

1. Name of the work :

Supply, Installation, Testing & Commissioning of Electronic Equipment For Smart Class Room in the District of Kalahandi Smart Class for the year 2021-22

2. Supplier / Dealer:

An individual or a group of individuals, Dealer, joint venture/partnership duly authorized by the manufacturer for distribution/supply of their products.

3. Warranty:

A written letter from the manufacturer/dealer/supplier/bidder issued to the purchaser for an article promising to repair or replace the items, if necessary, within a specified period of time.

4. ELIGIBILITY CRITERIA

4.1 The dealers/ Supplier / Agent for items not manufactured by them can also participate in the bidding system having manufacturers' authorization certificate or authorized dealer/supplier authorization letter. If the firm is an authorized agent/dealer of that manufacturer, certified documentary evidence to this effect is to be attached along with the quotation/bid. This is necessary to ensure quotation/bid from a responsible party offering genuine product, also backed by warranty obligation from the concerned manufacturer.

4.2 The firm must have valid GST / GSTIN.

4.3 The firm must have valid income tax PAN & ITCC

4.4 The firm must have a minimum average annual turnover of Rs.50 lakh over last three years in the business.

4.5 The product must conform to minimum technical requirements/standards.

4.6 The annual turnover and work experience shall be relaxed for startups.

4.7 The bidder cannot participate in more than one bid for a particular work.

The bidder failing to comply with the above will summarily be rejected.

5. SCOPE OF THE WORK


The broad scope of the work shall be supply, installation, testing & commissioning of the system with two year warranty in 99 no. of high schools. The equipment will be delivered and installed in the specific high schools, as attached at **Annexure- 'A'** or any other high school as mentioned in the work order.

General Instructions

Interested bidders are advised to view the detailed tender documents before submission.

Earnest money as specified in bid i.e. Rs. 1,23,000/- (Rupees-One lakh twenty three Thousand only) shall be deposited in shape of Demand Draft from any nationalized bank in favour of District Education Officer, Kalahandi payable at SBI, Bhawanipatna (Main Branch). Another 1% of the contract amount shall be deposited during signing of agreement. The EMD shall remain valid at least three month after satisfactory completion of the work.

The bidders shall submit reports on their financial standing such as audited profit and loss statements, balance sheet, Auditors reports for the past three years. All accounting statements must be duly audited and submitted along with the auditors' note accounts and accounting standards.

- The supplied materials shall strictly in accordance with the specifications as mentioned in the bid; otherwise the bids will be rejected.
- Since timely execution of works is the essence of the contract, requests for extension of time shall not ordinarily be entertained.
- Notice inviting tender, bid documents, prescribed Technical bid, Financial bid, terms & conditions shall form the part of the tender/bid.
- Bidders may in their own interest visit the sites
- All Taxes applicable at the time of supply will be admissible.
- In case of supply of any defective material or substandard material, the materials will be rejected. It will be the responsibility of the supplier for taking back or replace the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the purchaser, it shall be the right to suitably dispose of the same and to forfeit the amount from bidder.
- District Education Officer, Kalahandi will not be responsible for any incidental or consequential losses of the firms.
- During the warranty period District Education Officer, Kalahandi reserves the right to cross check the performance of the systems with reference to specifications.
- Deviations in terms and conditions, specification of material etc. will not be accepted under any condition.
- The Financial and Technical bid along with the photo copies of documents in support of meeting the minimum qualifying requirement of the tender shall be given as attachments.
- Prices quoted must be firm and fixed. The rate quoted should be including cost, GST, Transportation, Installation & other taxes. It shall be quoted in both figure and word. No price variation/escalation shall be allowed.
- Conditional tender shall not be accepted. Therefore, it is in the responsibility of the bidders not to write anything extra in the Price Bid except price.
- Canvassing in any manner shall not be entertained and will be viewed seriously.
- The bidder is not entitled to withdraw his offer after opening of tender.

6 Submission of Bids:

- 6.1 The bids must be submitted in double cover system. The technical bid and price bid are to be placed in two separate envelopes super-scribed, "technical bid / price bid" and then putting them in a single cover super-scribing name of work by registered / speed post / by hand only.
- 6.2 The bidder must ensure that the bids are submitted to the appropriate authority as specified place, date and time indicated in the Tender notice/ bid documents.
- 6.3 The bidders are required to provide their phone numbers for necessary communication.
- 6.4 Bidders shall not be permitted to alter or modify their bid after expiry of deadline for receipt of bid.
- 6.5 All the bid documents shall be self-attested in all pages failing which the bid will be rejected.
- 6.6 The bids received after the scheduled date and time will not be entertained and non-acceptable.

7. Late Bids: The bids receipt beyond the prescribed date and time shall not be entertained.

8. Modification and withdrawal of Bids:

- No bid shall be withdrawn after the deadline for submission of bids. Withdrawal/modification of bid before the expiry of bid validity shall result in forfeiture of Bidder's EMD.

9. Procedure for opening the Bids:

- 9.1 The Technical bid will be opened first. The financial bid will be opened next, if the technical bid of a bidder is found responsive. If the technical bid of a bidder is found irresponsive then it will be rejected and the price bid will not be opened.
- 9.2 If due to any reason the due date is declared as a holiday the bid will be opened on next working day at the same time & venue.
- 9.3 The bid will be opened in the presence of the bidders or their authorized representatives. The authority will not be responsible, if the bidder is not present.

10. Technical Evaluation Criteria

Bidder, who fulfils all the below mentioned technical evaluation criteria will be considered eligible to compete in the financial bid.

- vii. OEM Authorization certificates or authorization from authorized supplier/ authorization vendor etc.

The bidder must submit the Photo copy of the OEM authorized suppliers/vendors authorisation certificate.

Note- All the documents must be self-attested by the Bidders.

11. Advance to Contractor

11.1 No advance shall be made to the supplier.

11.2 The payment shall be made on satisfactory completion of the installation.

12. Acceptance of the Bid Documents

When the person to whom the proposal is made signifies his assent thereto, the proposal is said to be accepted provided it shall be a responsive bid. A proposal when accepted becomes a promise.

13. Cancellation/Rejection of the Bid Documents

The bids shall be cancelled or rejected on the following grounds:

- a. Special conditions which are not in the tender notice and which are unacceptable.
- b. Indefinite conditions which will make difficult to access the financial implications.
- c. Tenders being incomplete in some important aspect.
- d. Failure to specify the time within which the work can be completed.
- e. Failure to deposit the specified amount of earnest money.
- f. Unduly low and unworkable tendered rates.
- g. Irrational rate in different items of a tender.
- h. Failing to submit necessary documents as asked for.

The District Education Officer, Kalahandi reserves the right to accept or reject any or all bids without assigning any reason thereof.

14. COMMERCIAL TERMS & CONDITIONS

14.1 Quoted Rate

The quoted rate shall be the unit cost of the material. This shall be the basic cost including cost of packing, forwarding, loading & unloading charges, cost of insurance and transportation for destination where the system will be installed as per the work order.

14.2 Tax & Duties etc.

Applicable as per GST Rule.

14.3 Earnest Money Deposit

- Earnest money is required to be deposited along with the bid without which the bid will not be accepted.
- No interest will be payable on the EMD amount under any circumstances.
- Earnest money can be deposited in shape Demand Draft from any nationalized bank in favour of District Education Officer, Kalahandi payable at SBI, Bhawanipatna (Main Branch).
- EMD shall be refunded to the unsuccessful bidders after finalization of the bid without any interest after finalization of bid.
- EMD shall be refunded to successful bidder(s) six month after satisfactory completion of the work.
- EMD shall be forfeited in case of non-compliance of the purchase order by the successful bidder within the time limit.

- In case of claim for exemption from deposition of Earnest money, sufficient proof in support of claim for exemption of EMD is to be attached with the bid.

15. Undertaking as to litigation/Black Listed

- The bidder shall submit self-certified undertaking to the effect that there is no major legal cases pending against it or him and not being black listed by Govt. of Odisha and any other Govt. of union territory and other authorities.

16. AWARD OF WORK:

- The L1 bidder will be intimated with letter of award (LOA) before signing of agreement.
- The purchase order shall be given by the District Education Officer, Kalahandi
- The quantity of order may vary from the numbers specified in the financial bid.

17. DELIVERY PERIOD/PROGRAMM EXECUTION SCHEDULE

The delivery period shall be one calendar month as specified in the bid documents.

18. VALIDITY OF OFFER

The offer will remain valid for a period of ninety days from the date of receipt of the bid. The validity can be further extended with mutual consent.

19. ESCALATION

No escalation clause except the admissible tax component under the period of consideration shall be accepted.

20. GST

The bidders must submit attested copy of valid GST certificate along with the bid. The bid shall not be considered without this document. The original certificate shall be produced at the time of opening of the bid or before placement of purchase order if required.

21. The supplier should submit self-attested copies of the Income tax clearance certificate for last three years.

22. WARRANTY

22.1 The Systems shall be warranted against any manufacturing defect or bad workmanship for a period of 2 years from the date of commissioning of the systems. Warranty certificate to the above effect must be furnished along with the commissioning report. Any defect noticed during warranty period should be rectified/replaced by the supplier free of cost with due intimation to the District Education Officer, Kalahandi. Care shall necessarily be taken to make the system operational within a week of reporting of defect. If the system is not made operational within fifteen days, District Education Officer, Kalahandi may rectify the same and all expenses incurred there to shall be met out of the dues of the vendor.

22.2 The repair and maintenance including replacement of defective accessories of the system during the warranty period shall be done by the bidder at his own cost.

23. LIQUIDATED DAMAGES

In case the supplier fails to complete the work within the stipulated period the liquidated damages maximum upto 10 percent shall be recovered over the left over work.

24. PAYMENT

24.1. Payment shall be made by concerned SMC/SMDC of High Schools on satisfactory installation of the system 7 days after compiling of following point:

- Post Installation verification / confirmation as per technical requirement by District level technical team within 7 days.

24.2. Modes of Payment

The payment shall be made in INR through NEFT/RTGS etc.

24.3. Deduction of Income Tax, Service Tax, etc. at Source from Payments to Suppliers

This will be done as per the existing law in force during the currency of the contract.

25. EXECUTION

Execution of work shall be carried out diligently & shall be completed within allotted period.

26. SETTLEMENT OF DISPUTE

In case of any dispute arises between the supplier and purchaser shall be resolved amicably by mutual understanding. If the party fails to do so, it shall be settled through arbitration under the jurisdiction of Bhawanipatna Court only as per Indian Arbitration and Conciliation Act-1996.
