Sealed quotations / applications, as per guidelines Vide Govt. No.10638/FARD, Dt.25.08.2021 enclosed herewith, are invited from (i) the interested Facilitating Non Governmental Organisations (FNGO) for implementation of Animal Helpline (AHL) and providing Veterinary Ambulance Services at Bhawanipatna (urban area) of Kalahandi district engaging suitable vehicle on hire (preferably vehicle with lifting system) and (ii) service providers for engagement of a contractual driver for driving the Vety. Ambulance (to work in Bhawanipatna urban area) vehicle in two shifts. The NGOs already applied Vide this office no. 3378 dt. 29.12.21 and 3382 dt. 29.12.21 for AHL & Vety. Ambulance in earlier time need not apply again.

For each of above assignments like AHL & Vety. Ambulance and engagement of driver on outsourcing basis, an EMD (refundable) of Rs.10,000/- (Rupees Ten thousand) only and paper cost/processing fee (non refundable) of Rs. 500/- (Rupees Five hundred) only need to be deposited separately in shape of valid Bank Drafts drawn in favour of CDVO, Kalahandi cum Member Secretary, District SPCA, Kalahandi.

The selected FNGO will have to abide by all terms and conditions as provided in aforementioned guide lines of the Govt. in F & ARD Dept. Interested FNGO should enclose all documents as mentioned in the guidelines including bank drafts. The applications filled in all respect need to reach during office hours only by **22.04.2022**. Application(s) reached in any manner after 22.04.2022 will not be entertained.

The selection of FNGO will be liable for cancellation, at any point of time, in case it is found to have been blacklisted by any Govt.organization/Dept. and the documents submitted are proved false and fabricated/manipulated, besides imposition of fine, forfeiture of EMD, penal action as per provision and such other actions including recommendation for black listing the NGO by competent authority. The authority reserves the right to cancel this notice at any time without assigning any reason thereof. The documents received from NGOs will never be returned back.
