Sealed quotation addressed to the Land Acquisition officer, Kalahandi accompanied by a Demand draft amounting to Rs.1000/- Rupees (One Thousand) only drawn in favour of LAO, Kalahandi payable at SBI, Bhawanipatna which shall be subjected to refund immediately except in case of highest offer accepted by the committee. The last date of submission is 23.05.2022. The quotations will be opened in the office chamber of the Additional District Magistrate Kalahandi in the presence of committee member and the Tenderers or their authorized agents on dated 23.05.2022 (10.00 AM). The highest offer at or above the minimum price shall be approved by the committee then and there. The highest Tenderer shall deposit 25% of the bid amount immediately after announcement and the rest amount within 7 days of the approval of the offer with the LAO, Kalahandi.

The bidders will receive the vehicle from the garage at LAO, Kalahandi within 7 days from the date of depositing the full amount of the tendered/negotiated money otherwise the amount deposited shall be forfeited and the bidder will be seized to have any right on the auction sale. Custody or safeguard of the vehicle shall be responsibility of the tenderers/ party and to claim or complaint on that account shall not be admissible. Relevant documents along with the vehicle may be inspected in between 08.00 AM to 11.00 AM from 09.05.2022 to 21.05.2022 on prior appointment with LAO, Kalahandi. On failure to make payments as aforesaid, the deposits (including earnest money) shall be forfeited and the vehicle put to fresh tender as the case may be.

The vehicle shall not be delivered to the Tenderer/party until after full payments and compliance with requisite formalities. Tools implements and spare parts shall not be delivered with the vehicle. On failure to remove the vehicle within the time aforesaid ground rent at the rate of one percent of the tendered/negotiated amount shall be charged for each day or part of the day till the removal of the vehicle from the site.

Where the ground rent so charged exceeds the sale price deposited the tendered/party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle become absolute property of the Government free from all encumbrances and disposed of by fresh sealed tender as case may be.

The authority reserves the right to be accept, reject and cancel the tender without assigning any reasons thereof.
