V. SERVICE CHARGE @15/-

2. The Caterer should have a valid food license approved by FSSAI to run the catering in RSETI. However, experienced caterers may also participate in the tendering process. Preference will be given to caterers based in Bhawanipatna town.

3. The successful bidder would be required to execute a stamped agreement in prescribed format with the Director, SBIRSETI containing the detailed terms and conditions of supply of food items.

4. The catering bills will be paid on completion of course or on fortnightly basis as per mutual convenience on production of bills.

5. SBIRSETI will reserve the right to terminate the arrangement /engagement by giving 15 days prior notice to the caterer. No compensation shall be payable to the caterer by SBIRSETI for terminating the said agreement. The SBIRSETI also reserve the right to terminate the agreement/arrangement with immediate effect, if the caterer fails or neglects to take proper care or does any act jeopardizing the health and safety of the participants of the SBIRSETI training programme without serving the notice of 15 days as mentioned earlier.

6. The intending bidder shall deposit Rs.3000/- as caution money in shape of Bankers Cheque favouring the Director, SBIRSETI along with the sealed quotation. The unsuccessful bidders will be refunded their caution money after tender process is over. The caution money of the successful bidder will be adjusted towards the security deposit of Rs.10000/-in form of Draft/Bankers Cheque to be made by him in favour of the Director, SBIRSETI, Kalahandi. If he fails to do so within 7 days the caution money will be forfeited. The Security Deposit will be refunded on termination of the agreement without any interest.

7. The last date for submission of the sealed quotation at the office of the Director, SBIRSETI, Kalahndi is by 5 P.M. of 27/06/2022.

The sealed quotation will be opened in the office of the Director, SBIRSETI, Kalahandi in the presence of the Tender Committee comprising C.M., Lead Bank, Kalahandi, DDM, NABARD (Kalahandi), G.M., DIC (Kalahandi), Dy. C.E.O, ORMAS (Kalahandi), APD Credit, DRDA (Nodal Officer RSETI) and Director RSETI, Kalahandi on Dt. 28/06/2022 at 4 P.M.. The bidders or their authorized representatives May remain present at the time of opening of the tender if they so desire. No further intimation will be sent in this regrd.

9. The final selection will be subject to clearance from our SBI, Local Head Office, Bhubaneswar.
