8. Bids received online shall be opened at 11.30 A.M on dated 29.09.2022 in the Office of the Divisional Forest Officer, Ghumsur South, Bhanjanagar in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.




