**DETAILED TENDER NOTICE FOR ENGAGEMENT OF TRANSPORT AGENT  
FOR THE YEAR 2022-2023**

1. Sealed tender in the prescribed form are invited from intending Firms/individuals/Registered Transport Contractors/Agents for undertaking transportation of food stuff under Mid-Day-Meal feeding programme in Kalahandi District for the session 2022-2023. The approximate quantity of food stuff (rice) to be handled annually is 58487Qtls. and its total approximate value is Rs.16,58,10,645/- (Rupees Sixteen Crore fifty eight lakh ten thousand six hundred forty five)only .

The detailed tender papers along with prescribed Tender Schedule ( Annexure – I &II) can be obtained from the DPMU (MDM), Office of the District Education Officer, Kalahandi during the office hours from date 21/9/2022 to date 14/10/2022 on any working day on payment of Rs. 15000/- ( Rupees Fifteen thousand)only which is non-refundable through DD in favour of DEO-cum-District Nodal Officer (MDM) Kalahandi , Payable at Axis Bank, Bhawanipatna only and the money receipt thereof is to be submitted along with the tender documents. The same can also be down loaded from the official website <http://www.kalahandi.nic.in>. & the tender documents shall be submitted with a DD of Rs.15000/- (Rupees Fifteen thousand) only which is non-refundable drawn in favour of **DEO-cum-District Nodal Officer (MDM) Kalahandi payable at Axis bank, Bhawanipatna**towards the cost of tender papers.

2. The tender paper completed in all respect shall reach the District Education Office Kalahandi by registered /speed post service only during the office hours on or before 14/10/2022 and will be opened on 15/10/2022 at 11:00 AM in presence of the Tender Committee members/tenderers or their authorized agents .

3. The interested bidders must submit the Technical bid in an envelope super-scribed as "Technical Bid for Tender of Transportation of Mid Day Meal Food stuff in Kalahandi District for 2022-2023". The Financial Bid must be submitted in a separate envelope superscribed as "Financial Bid for Tender of Transportation of Mid Day Meal Food stuff in Kalahandi district for 2022-2023. Both these envelopes must then be placed in a third envelope super-scribed as "Tender of Transportation of Mid Day Meal Food Stuff in Kalahandi district for 2022-2023". The tenders received beyond the scheduled date and time shall be outrightly rejected. The undersigned reserves the right to reject/ cancel /withdraw any or all the tenders without assigning any reason thereof and shall bear no responsibility what so ever consequent upon such decisions.

4. The rate of transportation shall be within the maximum ceiling price of Rs. 150 /- (Rupees One Hundred Fifty) only per Quintal which shall be finalized by the committee.

**5 a) TECHNICAL BID**

**The Technical bid should contain the following: -**

- (i) Attested copy of recent solvency certificate for Rs. 1.00 Crore (One crore) from the competent authority along with tender paper(s) should be furnished failing which tender will be liable for rejection.
- (ii) Certificate from the District Collector/ Any Govt. / Semi Govt. organization etc. about past experience and performances, if any in handling transport work shall be furnished along with the tender papers.
- (iii) Pursuance to the Finance Department Memorandum No.8943/F dated 18.03.2021 & subsequent OM No 8475/F dated 05.04.2022 in wake of slowdown of the economy due to COVID-19 pandemic, all the interested bidders shall be exempted from depositing earnest money deposit while submission of their bid. In lieu of such Bid Security (EMD), interested bidders shall submit "**Bid Security Declaration**" in the prescribe format at "**Appendix-I**".
- (iv) Attested Copy of the **PAN card, GST registration certificate** & attested copies of Income Tax return for the last three years i.e., 2019-20 ,2020-21 & 2021-22 shall be furnished along with the tender documents.
- (v) List of trucks owned by the tenderer with up-to-date documents (Xerox copies duly attested) shall be furnished along with tender. The tenderer should have minimum three trucks of his own and additional 10 trucks on lease basis with attached copies of supporting documents of the vehicle such as R.C. book/Fitness/Road permit, career service etc. However, the selected tenderer may be required to hire the required number of trucks as and when necessary to transport the stock on the basis of requirement furnished by the nodal ABEOs within the stipulated time.
- (vi) The vehicles must have all Odisha valid certificate of registration issued under OMV (Licensing of agents) Rules 5(1) of the carriage by Road Act 2007 & carriage by Road Rule 2011. No individual, firm, company and corporation shall participate in the tender process unless he obtains or possesses the agent license as mentioned in his/ her name (in case of individual) or in his/ her firm's name.
- vii) Attested copy of the firm registration certificate from IGR, Cuttack shall be furnished along with the tender paper.
- viii) Audited Balance sheet and PL Account for last two years i.e., 2020-21 & 2021-22 with a minimum turnover of Rs1 Crore for each year being certified by Chartered Accountant needs to be furnished.
- ix) An affidavit as per **Appendix-II** to the effect that tenderer and his family member should not be rice miller/ OSCSC Ltd. H&T Contractor Level- I & Level -II. along with noninvolvement & non pendency of any criminal offences and also about no govt. dues pending against him and not blacklisted by Govt. /Semi Govt./ PVT. organization must be enclosed with the tender paper
- x) Original Tender document in Annexure- I of each paper are to be signed by the tenderer.
- xi) Attested copy of deed of partnership/Xerox copy of power of attorney holder (if the firm is partnership firm or any other).

**5 b) FINANCIAL BID**

The financial bid should contain the transportation cost in the prescribed format in annexure-II of the tender paper and the rate of transportation cost quoted shall be at the flat rate per quintal irrespective of distance & the price quoted must be inclusive of loading, unloading, transportation, other incidental charges and taxes if any and delivery OSWC/FCI Depot. Kalahandi to all School point as per the diversion order issued from the DPMU,MDM, Kalahandi within the specified period. The stock should be handed over to the headmaster with 4 numbers of proper acknowledgement. It is the responsibility of the tenderer/transporting agent to lift the rice from the OSWC/FCI depot on proper weighment and deliver the same to the school point on proper weighment and in no case short supply or delivery and deviation in quality shall be allowed. TDS @2% of transportation cost will be deducted for the Year 2022-2023.

The Financial bid should be legible and filled in properly without any correction/over writing. The rate and units should be written both in words and figures and it should be in proper order. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and under no circumstances the extra amount will be paid over and above the rate approved by the committee.

**OTHER TERMS AND CONDITIONS.**

6. The successful tenderer shall be required to lift rice from the nearest OSWC/FCI depot of OSCSC Ltd., Kalahandi and will transport directly to all the School point of the district as per the direction of Collector/Dist. Project Management Unit (MDM), Kalahandi. The rice has to be delivered at all the school point at not at any intermediate point by the transporter.
7. Accepting Authority shall have the right not to accept tender(s) of firms/parties who have not performed satisfactorily in preceding year(s) under Govt. of Odisha.
8. Conditional tender will not be accepted.
9. The detailed tender papers should be returned with the tender duly signed in each page by the tenderer as a token of acceptance of the terms and conditions in the technical bid.
10. Firms/persons having adverse records will not be entertained.
11. The successful Tenderer shall furnish, within seven working days of acceptance of his tender, a Security Deposit for the due performance of his obligations under the contract. A sum equivalent to 1% of the value of contract i.e. Rs.17,00,000 shall be submitted electronically through NEFT/RTGS/other electronic means in favour of the District Education Officer-cum District Nodal Officer, (MDM) Kalahandi towards **security deposit.**

12. The successful tenderer(s) shall have to enter into an agreement in a non Judicial stamp paper worth Rs.100/- with the District Education Officer on behalf of Collector & District Magistrate, Kalahandias per terms and conditions, as specified in the agreement form at his/their own cost on receipt of intimation of acceptance of his/their tender.
13. The Authority may terminate the contract for violation of terms of Agreement or for any other reason to be recorded in writing.
14. In case of violation of condition(s) of tender, the concerned Transport Agent can be booked under IPC, Essential Commodities Act, and Prevention of Food Adulteration Act and Prevention of Black Marketing Act.
15. The Authority reserves the right to reject any or all tenders received without assigning any reason thereof.
16. The authority will not be responsible for any mishap during the transportation of rice from OSWC /FCI depot of OSCSC Ltd., Kalahandito all school point.
17. The food stuff (rice) shall be transported directly to school points. The delivery shall be made at the school point and challans of the Transporting Agents duly acknowledged by the Headmaster shall be submitted within 03(three) days to the concerned BEO, who in turn shall submit the consolidated acknowledgement certificate to District Education Officer-cum-District Nodal Officer, DPMU,MDM,Kalahandi for further action.

#### NATURE OF WORK AND PAYMENT

1. The work is to be carried on with due diligence and in accordance with the instruction to be issued from time to time by the School and Mass Department/ Collector, Kalahandi/District Project Management Unit, MDM, Kalahandi.
2. The agent will hand over delivery Challan in support of delivery of the stock at all School point duly signed by the concerned Headmaster or stock in charge as the case may be, as a token of acknowledgement of the stock supplied to the School point in every month to the Block Education Officer. The concerned BEO will certify the challan stating the total quantity of rice supplied at the school point by the transport agent.
3. Payment shall be made against submission of bills on completion of delivery of stock as per the orders of the competent authority on production of certificate of the concerned Block Education Officer stating the total quantity of rice supplied at the school point by the transport agent at the approved rates incorporated in the agreement. The D.P.M.U (MDM) District Education Officer, Kalahandi shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. No advance payment will be made. The payment is subject to availability of allotment of funds.
4. The Collector may terminate the contract for violation of terms of agreement.
5. Payment shall be made as per approved rate incorporated in the agreement.
6. No request for enhancement of approved rates shall be entertained during the term of agreement.

**OFFICE MEMORANDUM**

**Subject: Bid Security / Earnest Money Deposit (EMD)**

To safeguard against a bidder's withdrawing or altering its bid during the bid validity period, Bid Security (also known as Earnest Money Deposit) is obtained from bidders except those who are exempted from paying Bid Security as per para-21 of FDOM No 4939/F Dated 13.02.2012. Besides, the State Government have exempted Micro and Small Enterprises (MSEs) as defined in Odisha MSME Development Policy, 2016 and Start-ups as defined under Odisha Start-ups Policy, 2016 from payment of Bid Security while participating in tenders vide FDOM No 27928/F Dated 16.10.2020.

2. The State Government is in receipt of many representations that on account of slowdown in economy due to the pandemic, there is acute financial crunch among vendors, which in turn is affecting timely execution of the contracts. It has also been represented that this may affect the ability of vendors to bid in tenders and hence reduce competition. Besides, Government of India have made provision in Rule-171 of General Financial Rule, 2017 asking the bidders for executing a "**Bid Security Declaration**" in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents.

3. Considering the difficulties faced by the vendors and to facilitate competition in wake of slowdown of the economy due to Covid-19 pandemic, it is hereby decided that **no provisions regarding Bid Security should be kept in the Bid Documents and only provision**

for "Bid Security Declaration" should be kept. Further, wherever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender.

4. These instructions shall be applicable for all kinds of procurements viz Goods, Consultancy, Non-consultation and Works.

5. These instructions shall be deemed to be a part of Odisha General Financial Rules.

6. Works Department shall make suitable amendment in the relevant provisions of OPWD Code.

7. **The above instructions will be applicable for all the tenders issued till 31.12.2021.**

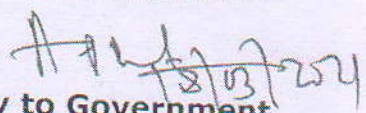

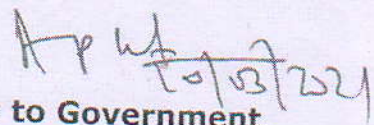

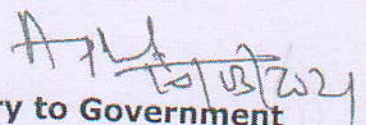
