The BDO, Junagarh on behalf of Governor of Odisha invites **Percentage Rate bids** for the construction of works detailed in the table below in **Single Cover** system from the Class of Contractors mentioned in **column-5** registered with the State Governments and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil works by registered / speed post & Courier service only. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under the state government has to register under the appropriate registering authority of state Government of Odisha in appropriate class for eligibility before signing of the agreement.



3. Bid documents consisting of specifications, the schedule of quantities and the set of terms & conditions of contract and other necessary Documents can be seen in the website [www.kalahandi.nic.in](http://www.kalahandi.nic.in).
4. Bids must be accompanied by Earnest Money Deposit/ Bid security of the amount specified for the works in the col.6 of above table, pledged in favour of the B.D.O, JUNAGARH and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire Machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.
5. The Bid documents will be available in the [www.kalahandi.nic.in](http://www.kalahandi.nic.in) from 10.00 hours of 22.09.2022 to 17.00 hour of 29.09.2022.
6. The Bidder must also have the work experience of similar nature of work equivalent to the amount for which he/she intends to participate.
7. Bids shall be received only by Registered/Speed Post or courier service on or before 17.00 hour of 29.09.2022. The envelope containing Bid must be superscribed as "BID DOCUMENTS FOR THE WORK CONSTRUCTION OF CDPO OFFICE BUILDING AT JUNAGARH".

8. The bids shall be **opened at 11.00 Hours on 30.09.2022** in the office of the BDO, Junagarh in the presence of bidders or their authorised representatives. If it happens to be a holiday, the same will be opened in the next working day at the same time and venue.
9. The cost of bid document shall be annexed separately in shape of demand draft drawn in favour of **BDO, Junagarh** on any scheduled bank mentioned under Column-7 as above, payable at **Junagarh** with the bid documents super scribing thereon the "*Cost of Bid Documents*".
10. **The items covered in Clause No-124 of DTCN for Road work and Building work are required as ESSENTIAL CRITERIA for eligibility for qualification.**
11. Other details can be seen in the bidding document.
12. This Notice is to be read with all clauses/ addendum.
13. Checklist to be duly filled in.
14. The intending Bidders are required to furnish their e-mail address and cell Phone No so as to inform them anything relating to the tender.
15. If any intending bidders wish to withdraw from participation in the bid, He/She can freely withdraw from the participation before scheduled date and time of closure. In case, the 1st lowest Bidder or even the next lowest Bidder withdraw in series one by one in later stage, thereby, facilitating a particular Bidder for award, then they shall be penalized with adequate disincentives with forfeiture of EMD/Bid Security unless adequate justification for such back out is furnished. Appropriate action for blacklisting the bidder shall also be taken apart from disincentivising the bidder.
16. The authority will not be held responsible for any delay in receipt of tender documents due to postal delay or any other reasons thereof.
17. Any corrigendum/ Addendum will be displayed in the website [www.kalahandi.nic.in](http://www.kalahandi.nic.in) only.
18. The authority reserves right to cancel any or all bids without assigning any reason thereof.
19. The 1st lowest bidder must produce the original documents including its original EMD within the stipulated time period failing which action shall be taken to blacklisting Agency.
20. As per amendment to Para 3.5.5 (V) of Note-II of OPWD Code, Vol-I by modification vide Works Department, Government of Odisha Office Memorandum No-07556900032016-5288/04.05.2016, the successful bidder is required to furnish the Additional Performance Security when the bid amount is less than the estimated cost put to tender. In such event, the bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Term Deposit Receipt duly pledged in favour of **BDO, Junagarh within 7 days after declaration as L2 Bidder.**
21. The rate quoted by agency must be excluding cost of GST. GST as per statute shall be paid in each running work bill as admissible on production of Tax Invoice. No claims as extra payment towards GST shall be entertained.






