4. The bidders must possess compatible Digital Signature Certificate (DSC) of Class – II or Class – III. Bids shall be received on "ONLINE" on or before 11.00 AM of dt: 10.10.2022.
5. Bids received online shall be opened at 12.00 PM on 10.10.2022 in the office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC, if the office happens to be closed on the last date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue.
6. In case the bidder intended to quote less price than the amount put to tender shall be abide by the Government Order No. 4559 Dt. 05.04.2021 i.e. amendment to Para -3.5 (v) of OPWD Code, Vol-I with modification that "Additional Performance Security" shall be deposited within 7 (Seven) days of the issue of the "Letter of Acceptance" by failing which the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder. Other detail can be seen in the bidding documents.
