01. The tender schedule will be available in the kalahandi district website <http://www.kalahandi.nic.in> from 06.10.22 to 26.10.22 upto 5.00 PM on payment of Rs1000/- (Rupees One thousand) only in shape of Demand Draft.
02. The tenderer should quoted the rate to be deposited clearly both in figures as well as in words. This amount is to be deposited in advance at a time except Daily / Weekly Market in shape of Demand Draft in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna. No cash or personal cheque will be entertained in this regard.
03. The tender for Daily / Weekly Market should be accompanied with 3 (three) month quoted value and for other property 1 (one) year quoted value as the Security deposit amount in shape of Demand Draft in favour of the Executive Officer, Bhawanipatna Municipality payable at Bhawanipatna. No cash or personal cheque will be entertained in this regard.
04. The Security deposit will be refunded to the un- successful tenderer within a period a period of one month of issue of order on request.
05. The successful tenderer has to execute an agreement with the undersigned within 07 (Seven) days from the date of issue of order. Failure to deposit the tender amount as well as failure to execute agreement within the stipulated time of 07 days, the next bidder will be considered for the said lease and in that case the security deposit will be forfeited.
06. The tenderers should submit separate tender paper for lease of each Municipal property.
07. The Agency should clear all the Municipal dues before apply for this lease failing which his case will not be entertained.
08. The agency will collect hoarding charges from all display board having size 12' x8' or above in respect of Advertisement Hoarding.
09. Bidder must have 3 (three) years experience in outdoor Advertisement in respect of Advertisement tender
10. The rate of collection of market fees for Daily / Weekly Market @ Rs 10/- (Rupees Ten) only per trade and Rs 05/- (Rupees Five) only per animal from slaughter respectvelly.
