

Detail Term and Conditions

1. The intending Dealer/Firm/Agency/Company would have to bring sample of the material to be provided which will be evaluated by the committee. The bidder selected after this scrutiny/evaluation will be eligible for opening up of the financial bid. The financial bids would be opened @5.30 P.M after completion of Technical valuation in office of the Sub-Collector, Dharmagarh.
2. The Bidder must submit separate sealed envelope for Technical & Financial bid for each equipment / machine.
3. The Agency/ Firm must submit valid updated Income Tax return for last 3 (three) years.
4. The Agency/Firm must provide annual maintenance facility.
5. At the time of opening of tender the DEMO of the machine/ equipment shall be given by the suppliers in front of purchase committee. Financial bid for the machine / equipment shall only be opened after having recommendation from the committee against technical evaluation.
6. The Agencies shall be able to supply machine/equipment within 7 (seven) days from the date of issue of supply order.
7. Placing of order for the required number of machine/equipment will be decided by the Mukhiguda H.I.R.M.C.
