

Sealed tenders/quotations are invited from the interested Travel Agencies/ Tour Operators/ Private Individuals for providing Non-A.C. Diesel/Petrol driven vehicles (**Bolero/Scorpio/ Ertiga**)

i) On Monthly rental basis without Driver for use in District Project Office,SS,Kalahandi.

ii) On daily rental basis including driver for use in DPO,SS, Kalahandi which will confirm to the Terms and conditions (**Annexure-II**) available in the District website, www.kalahandi.nic.in. or on the notice board of the office of the DEO-Cum-DPC,SS,Kalahandi for the purpose.

1. The vehicle must be in Road worthy condition & shall not be more than **3 years old** from the date of initial registration and must have valid Registration certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit proof, up to date tax payment etc. which are mandatory for plying of the vehicle.
2. The monthly hire charges without driver and daily hire charges with driver be quoted separately in the general bid information form **Annexure-III** (Excluding fuel and lubricants)
3. The details of the make and year of manufacture of the vehicle, registration number, mileage(Kilo meter covered per litre) in the general bid information to be furnished with the Tender (in the form enclosed as Annexure- III).
4. The Quotation completed in all respect should be super-scribed as "**Quotation for engagement of vehicle for DEO-Cum-DPC,SS,Kalahandi**", should reach the undersigned on or before 19-12-2022, 1PM through Registered Post /Speed Post only. The same shall be opened as per the convenient of the committee members in presence of the bidders or their authorized representatives, which is not mandatory. The date of opening will be intimated through Dist.website/ Mobile.
5. The application form of tender containing General Bid information and term and conditions for Hiring of vehicles etc. will be available in Kalahandi District website, i.e www.kalahandi.nic.in.
6. The cost of application with tender paper is Rs.200/- which should be deposited in shape of Bank Draft drawn in favour of DPC, SSA, Kalahandi. which is not refundable with the application form.
7. In case of requirement of any corrigendum the same will be uploaded in the District website, i.e www.kalahandi.nic.in for which no notice will be given in the newspaper. The bidders are therefore informed to visit the said website frequently.

TERMS AND CONDITIONS FOR HIRING OF VEHICLE


The following terms and conditions must be fulfilled by the bidders for providing a vehicle on hire, monthly and daily rent basis.

1. The hired vehicles, during the period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Fitness Certificate, valid Contract Carriage Permit / Proof of update Tax payment etc. The DEO-Cum-DPC, SS, Kalahandi, shall not be responsible for any damage/ loss caused to hired vehicle or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner of the vehicle shall be responsible for all such litigation.
2. The hired charges to be paid after the deduction of income Tax or any other Tax as applicable by law for monthly basis is final but does not include cost of diesel, petrol which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box and differential, coolant, tyres and tubes, battery etc. will be borne by the bidder.
3. The successful bidder has to deposit Rs.5,000/- (Five thousand only) as Security amount.
4. It shall be the responsible of the bidder to provide a good driver having valid License in case of daily hire vehicle.
5. The salary of the driver shall be borne by the owner of the vehicle in case of his Driver .
6. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
7. In case of the vehicle does not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source with same cost.
8. The vehicles shall report for duty for minimum of 25 days in a month.
9. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
10. Monthly hire charges and reimbursements towards the cost of P.O.L of the owner/driver (in case borne by them) will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider/ bidder and no advance payment will be made.
11. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
12. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
13. In case the service provider/ Bidder intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.



14. If the bidder violates any of the terms of contract, the DEO-Cum-DPC, SS, Kalahandi, shall forfeit the entire amount of security deposit.
15. The vehicle owner/ bidder should apply for engagement of his vehicle for DEO-Cum-DPC,SS, Kalahandi, separately.
16. The list of bidders will be prepared on the basis of tenders received in respect of DEO-Cum-DPC, SS, Kalahandi, and final selection will be made by the committee.
17. The bidder/ vehicle owner should mention on the top of the cover/ envelop as "Tender for hire of vehicle on .monthly/ daily basis" and their address and phone No. on be left side of cover.
18. The tender form must be signed by the vehicle owner/ service provider/ bidder and properly sealed and also attached with all relevant documents including drafts as per the terms and conditions.
19. In case of requirement of any corrigendum the same will be uploaded in the District website, i.e. www.kalahandi.nic.in for which no notice will be given in the newspaper. The bidders are therefore informed to visit the said website frequently.


