SECURITY SERVICES**A. Background:**

Odisha Rural Development and Marketing Society (ORMAS) was constituted in the year 1991 under Societies Registration Act, 1860 as an autonomous body under Panchayati Raj Department, Government of Odisha. ORMAS at District level known as ORMAS, Kalahandi. These units are functioning with the basic objective to help rural poor to make a better living by enabling them to improve their production, processing and marketing. ORMAS also act as a facilitating agency for implementation & monitoring of rural livelihoods programme in rural Odisha.

An exhibition in the most general sense is an organized presentation and display of selection of items. Exhibition/Mela has been part and parcel of entertainment and relaxation activity of our culture; ORMAS has used this medium as a channel to promote rural products made by the Institutions of poor.

ORMAS organizes exhibition in collaboration with Odisha Livelihoods Mission (OLM), Mission Shakti, DC (Handicraft), KVIC, KVIB Department of H & CI and NABARD with an objective to provide a platform to the rural producers to showcase their products for direct sale, interact and get taste, choice & preferences of urban consumers. It also helps the rural entrepreneurs identify livelihood opportunities and establish links with the markets in urban and semi-urban areas.

The overall objective of the mela is to popularize the ethnic and other rural products of Odisha and create opportunities for the artisans/producers to build up long term marketing tie-up with prospective buyers.

7. Minimum Qualification: Matriculation, +2 will be an added advantage
8. **Age group should be 18-45.**

2. Experience certificate for execution of similar nature of work should be enclosed
3. ORMAS, Kalahandi will not be responsible for any occurrence like theft & missing of any articles while deployment of guards during the exhibition period.
4. In case of any occurrence of theft, the Security Agency will conduct proper inquiry.
5. During inquiry, if it is found any fault or lapses on the part of security personnel for theft, the Security Agency will be responsible to pay the amount of loss towards theft of any article during the exhibition period from the premises.
6. Arrangement of lodging, boarding & logistics of the guards during the exhibition period will be the responsibility of the Security Agency.
7. The required no. of security personnel & the time period of deployment will be intimated separately, well in advance of each exhibition.
8. Sanctions of any advance will not be considered. Full & Final payment will be made on completion of event.
9. The rate offered by the firm should be valid for one year.
10. The Quotationer has to offer the price for all items together or else the tender paper will not be considered for evaluation.
