IMPORTANT INFORMATION TO THE BIDDER


2. The vehicle must be in Road worthy condition & shall not be more than **3 years old** from the date of initial registration and must have valid Govt. registered number for the purpose of Commercial use. Registration certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of the vehicle.
3. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. The Hiring of vehicle on Call Basis rate will be quoted separately form **Format – A** (Excluding fuel and lubricants)
6. The details of the make and year of manufacture of the vehicle, registration number and name of the Driver with valid Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Tender (in the form enclosed as (**Annexure- III**) .
7. The Quotation completed in all respect super-scribed with "**Quotation for engagement of vehicle for DPC,RTE-SSA,Kalahandi at District Level**" should reach the undersigned on or before **29.08.2018** by 1.30 P.M. through Registered Post /Speed Post only, DPO is not responsible for any postal delay. The Tender shall be opened on the same day at 4 P.M. in presence of the bidders or their authorized representatives.
8. The application form of tender containing General Bid information and term and conditions for Hiring of vehicles etc. will be available with the DPC,RTE-SSA,Kalahandi on payment of Rs.100/- in shape of Bank Draft drawn in favour of DPC,RTE-SSA,Kalahandi. In case the application form is down loaded from Kalahandi District website, i.e www.kalahandi.nic.in ,the applicant shall furnish a Demand Draft for an amount of Rs.100/-(Rupees One hundred)only towards the forms cost of tender paper along with the tender form.

TERMS AND CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled bidder for providing a vehicle on hiring of vehicle on call rent basis.

1. The hired vehicles, during the period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Fitness Certificate, valid Contract Carriage Permit / Proof of update Tax payment etc. and Driving License of the driver available all the time. The District Project Co-ordinator, RTE-SSA, Kalahandi, shall not be responsible for any damage/ loss caused to hired vehicle or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner of the vehicle shall be responsible for all such litigation.
2. The hired charges to be paid after the deduction of income Tax or any other Tax as applicable by law for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box and differential, coolant, tyres and tubes, battery etc. will be borne by the bidder.
3. It shall be the responsible of the bidder to provide a good driver and the salary of the diver shall be borne by the owner of the vehicle.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
5. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
6. In case the service provider/ Bidder intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
7. If the bidder violates any of the terms of contract, the District Project Co-ordinator, RTE-SSA, Kalahandi, shall forfeit the entire amount of security deposit.
8. The list of bidders will be prepared on the basis of tenders received in respect of District Project Co-ordinator, RTE-SSA, Kalahandi, and final selection will be made by the committee.
9. The bidder/ vehicle owner should mention on the top of the cover/ envelop **FOR HIRING OF VEHICLE ON CALL BASIS -2018.**
10. The tender form must be signed by the vehicle owner/ service provider/ bidder and properly sealed and also attached with all relevant documents including drafts as per the terms and conditions.


