Candidates are required to apply in prescribed format available in the website [www.kalahandi.nic.in](http://www.kalahandi.nic.in) and to submit along with a set of self attested copies of all certificates in support of age, qualification, experience, residence etc. Candidates are also required to submit two recent passport size colour photograph, an ID proof (Voter ID/ PAN/ Driving Licence /Passport/ Aadhar card) and recent (issued within 6 months) Caste & Residence certificate issued by the competent authority. ## **ELIGIBILITY & SELECTION GUIDELINE**

### **Name of the Position: AYUSH Doctor ( Ayurvedic/Homeopathic)**

**Eligibility** - Must have passed Bachelor Degree in Ayurvedic Medicine & Surgery (BAMS) / Bachelor Degree in Homeopathic Medicine & surgery (BHMS) from recognized university. The candidate must have completed compulsory internship, if any. Candidates having PG degree in BAMS/BHMS will be given additional weightage. Must have registered in the Odisha state council/Board of Ayurvedic/Homeopathic Medicine and should have valid registration certificate. No provisional registration is acceptable.

**Age:** 21 yrs – 37 yrs as on 01.06.2018

**Monthly Remuneration:** Rs.20,880/- + Other Allowances as admissible

**Mode of selection:** Ayurvedic and Homeopathic shall be recruited in the proportion of 9:8. Separate merit list will be prepared separately for Ayurvedic and Homeopathic Doctor.
