## QUOTATION CALL NOTICE.

Sealed Quotations are invited from interested reputed Travel Agencies/ Tour operators or private individuals for providing **01 numbers of Non-A/C Diesel driven vehicles (Preferably Bolero, Marshal, Tata Sumo, Mahindra Max)** having sitting capacity not more than 07 (Seven) including driver, which shall confirm to the Terms and conditions (Annexure-II) for official use by **DRDA, Kalahandi** on monthly rent basis for the purpose of field visits and monitoring of Rural housing Scheme.

- 1) The vehicle must be in Road-Worthy condition & shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. which are mandatory for plying of the vehicle.
- 2) The Driver of the vehicle must have a valid Transport Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The driver must be well behaved, gentle and obedient in nature.
- 4) A sum of **Rs. 5000/-(Rupees Five thousand)only** as EMD shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Project Director, Kalahandi payable at SBI main branch Bhawanipatna and submitted along with the tender as security deposit for vehicle. After completion of tender process, the EMD shall be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charges shall be quoted in the annexure – IV both in figure and word per month (excluding fuel and lubricants) and to be submitted along with annexure – II and III duly signed in each pages. The bid documents without signature will be rejected.
- 6) The vehicle must achieve a fuel efficiency of minimum of **10 km per liter**.
- 7) The details of the make and year of manufacture of the vehicle, registration number, mileage (Kilometer covered per liter ) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Tender (in the form enclosed as **Annexure-III**).
- 8) The Quotation in the prescribed format (enclosed herewith) completed in all respect should be reached to the DRDA, Kalahandi on or before **12.12.2018\_ by 4.00 P.M. by Registered Post / Speed Post only and shall be opened on the same day at 04.30 P.M.** in presence of the bidders or their authorized representatives. The bid received after above time and date is summarized be rejected.
- 9) The application form of quotation/ tender containing general bid information and terms and conditions for hiring vehicle etc. will be available with the DRDA, Kalahandi on payment of Rs. **105.00** (including VAT) from date **03.12.2018 to 12.12.2018** up to 10 AM. In-case the application form is downloaded from DRDA, website, the applicant shall furnish an account payee bank draft drawn in favour of the Project Director, DRDA, Kalahandi for an amount of Rs. **105.00** (Rupees One Hundred Five Only) towards the cost of application along with the application which is non-refundable.



TERMS AND CONDITIONS FOR HIRING OF VEHICLE


The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire, monthly rent basis.

1. The hired vehicles, during the period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Motor Vehicle permit / proof of up to date tax payment etc. and Driving License of the driver available all the times. The DRDA, Kalahandi hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicle or loss of life / injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner of the vehicle shall be responsible for all such litigation.
2. The hired charges to be paid after the deduction of income tax or any other tax as applicable by law for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box and differential, coolant, tyres and tubes, battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner of the vehicle.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
5. In case of the vehicle does not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty as and when required by the authority.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider/bidder and no advance payment will be made.



9. The vehicle **shall not be more than 3 years old** from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider/Bidder intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, the DRDA shall forfeit the entire amount of security deposit.
13. The vehicle owner / bidder should apply for engagement of his vehicle for DRDA, Kalahandi.
14. The list of bidders will be prepared on the basis of Quotations received in at DRDA, Kalahandi and final selection will be made by the District IAY Purchase committee of DRDA, Kalahandi.
15. The tender form must be signed by the vehicle owner / service provider/bidder and properly sealed and also attached with all relevant documents including drafts as per the terms and conditions.
16. The log book for the vehicle shall be maintained properly.
17. The servicing of the vehicle should be made at regular interval which should not be less than one month or not more than three months at the discretion of the officer in-charge. The servicing charges shall be paid by the bidder.
18. The undersigned reserves the right to reject all or any of the quotation without assigning any reason thereof.






