

The bidders or their representative may remain present at the time of opening of the tender failing which no complain/dispute in future shall be entertained.

1. The tenders should be sent in Sealed Cover addressed to Project Director, DRDA, Kalahandi-766001. The words "Printing of Hoarding under Rural Housing" should be prominently written on the envelope containing the tender.

3. The tenders will be opened on 14th December at 6.00 P.M.
4. No extra charges will be admissible. The successful bidder is to be install the Hoardings at Block HQ & District HQ.
5. The order can be terminated by the Project Director, DRDA, Kalahandi at any time without assigning any reason thereof. If the work of the L1 bidder is found to be unsatisfactory, the Project Director, DRDA, Kalahandi will be at liberty to entrust the same to the next lowest bidder. In this connection, the decision of the Project Director, DRDA, Kalahandi shall be final and binding upon the bidder.
6. Payment will be made on successful completion of the work as per govt. procedure.
7. Tender received after due date and time will not be accepted.
9. The Project Director, DRDA, Kalahandi reserves the right to reject any tender in whole or in part without assigning any reason thereof.

13. Bidders must furnish full data and information as required in this Tender Document.


