1. Sealed tenders are invited from intending registered printing Press/ supplying Agencies for Printing and supply of Kalahandi District.
2. The supplier should have upto date GST Registration Certificate(3B).
3. He should have PAN card No.(Photo copy of PAN card should be submitted)
4. The supplier should have not been blacklisted.
5. Rates should be quoted inclusive of inclusive of charges of GST/transportation and other taxes as applicable.
6. The District Administration will have no liability regarding transportation, loading and unloading of materials and all the materials ordered for shall be delivered at the designated place in good condition.
7. The tenderer should deposit EMD of Rs. 2000/-(Rupees two thousand)only in shape of Demand Draft in favour of in favour of " District Election Officer, Kalahandi" payable at SBI, Main Branch, Bhawanipatna.. Tenders without EMD Money will be liable for rejection. The EMD money deposited by the successful tenderer will stand converted to security deposit, which will be refunded after successful completion of supply. The EMD of unsuccessful tenderers shall be refunded after finalization of the tender process.

Money receipt in original in support of purchase of tender papers or Demand Draft of Rs.500/-(Rupees five hundred)only If the supplier has downloaded the Tender Paper from the district website he/she shall submit the DD of RS. 500/- payable at SBI, Main Branch, Bhawanipatna. to District Election Officer, Kalahandi".
9. The successful bidder has to supply within the stipulated period i.e.7 days of receipt of supply order.
10. The payment will be made after proper delivery of materials at the assigned place.
11. Under no circumstances shall the supplier appoint any sub-contractor or sublease the contract or else the order shall stand cancelled.
12. The detailed tender paper should be submitted with the tender duly signed by the tenderer as a token of acceptance of the terms and conditions.
