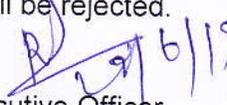

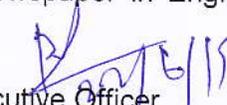

3. The materials shall be as per the specification only as mentioned in Quotation Schedule and strictly in accordance with relevant ISI Specification.
4. The quotationer must be quoted all the rate and taxes for each item according to the require specification clearly in word and figure.
5. The Tax and other Govt. tax as applicable from time to time will be borne by the quotationer.
6. The sample of the material is to be provided on the date of opening of the quotation.
7. The quotation should be sent to the Executive Officer, Bhawanipatna Municipality Dist- Kalahandi, Pin - 766001 through Speed post /Regd. Post Only.
8. Quotation received after due date and time shall not be entered and the undersigned will not be responsible for any kind of postal delay.
9. Delivery of the materials must be at Bhawanipatna Municipality Office premises within 15 Days from the date of issue of order at his own risk and own cost.
10. The quotation is valid for the year 2018-2019 for 1 (One) year (i.e. from the opening of the tender)
11. Any defective found in test operation is to be replaced/repared immediately in free of cost.

EMD cost shall be submitted in shape of Demand Draft/Bankers Cheque duly pledged in favour of "Executive Officer, Bhawanipatna Municipality "which shall be refundable to unsuccessful quotatioers in due course. No other mode of payment of EMD shall be accepted. Offers received without paper cost shall be rejected out rightly.
13. Paper cost shall be submitted in shape of Demand Draft/Bankers Checque / Cash duly pledged in favour of "Executive Officer, Bhawanipatna Municipality "which is non refundable . Offers received without paper cost shall be rejected out rightly.
14. The SD amount shall be deducted 3% from the supply bill.

15. Quotation received incomplete in any manner will be summarily rejected.
16. The quotationer shall submit the quotation call notice & quotation schedule duly signed by him with seal failing which the offer will be rejected and will not be considered in Comparative Statement.
