Sealed quotations are hereby invited from interested registered agencies/firms/service providers having valid documents like Certificate on GST/registration of Incorporation / labour registration / EPF / ESI / ISO certificate as per Govt. norms/Income tax TAN/PAN number/Adhaar card /work experience for latest six months and other requisite papers for the purpose of purely temporary engagement, on consolidated monthly remuneration as prescribed by the Govt., in the post of 8 (eight) peons and 3 (three) chowkidars (Group-D) under the CDVO, Kalahandi for a period of one year w.e.f the date of execution of engagement order. The service provider will have to sign an agreement with the Dept. with verification of original papers before issue of engagement order.

The candidate should be an Indian citizen and a permanent resident of Kalahandi district. He/she should have passed qualification of ME pass certificate with Odia language as a subject and be able to speak, write and read Odia language. He must have valid employment registration certificate in the district. He/she should bear a good character and be obedient in nature. In case of married, he/she should not have more than one spouse living. The candidate must not be less than 18 years and more than 32 years of age as on 01.01.2019. In case of SC/ST/SEBC/Women candidates the upper age limit is relaxable by five years. The candidates should be free from physical defect and mental infirmity. He/she should have good physique with minimum height of 5' (five feet) and unexpanded chest of 30"(thirty inches). In case of female candidate no chest measurement is required. He/she must know good cycling.

The candidates will be engaged to work at any Veterinary Dispensary and Livestock Aid Centres as per need of the district. It will be the responsibility of the selected agency / service provider to make payment to the candidates. The remuneration for the candidates will be paid to the Service providers only subject to availability of allotment and or prescribed rule of the Govt. of Odisha in force from time to time. The service provider will have to bear the total value of the Departmental property if any lost/damaged by the candidate sponsored by them. The service of the candidates/beneficiaries will be terminated at any time without assigning any reason thereof.
