

The agency having track record, capacity and relevant experience in this line is eligible to apply. The agency must be able to provide round the clock services to the District Head Quarter Hospital. Post /Courier only. The tender paper will be opened on **Dt: 16.08.2019 at 11AM** in the office chamber of the undersigned in the presence of committee members & all the renderers. TERMS AND CONDITIONS FOR OUTSOURCING BIO-MEDICAL WASTE OF KALAHANDI DISTRICT.

1. The agency will carry out the treatment and disposal of Bio-Medical Waste (BMW) generated at DHH, Kalahandi at BMW unit located at DHH, Bhawanipatna as per the rule and regulation of the state pollution control board.
2. The agency will be paid the cost towards the outsourcing of collection, transportation and disposal of BMW including the consumables i.e. color coded poly bags.
3. The agency will carry out the job for a period of one year from the date of signing of contract.
4. The entire BMW management and handling system shall be executed in conformity to the Bio-Medical Waste (Management and Handling) Rules, 2016.
5. The execution of such work shall include the **Waste collection** from the various points of the hospitals such as Indoor Wards, OPDs, Laboratories, OTs, Casualties, Blood Banks, dressing rooms, NRC, SNCU and all others where the same is generated. **Transport** of the collected BMW to the plant site for **Final treatment** and **Disposal** at the same. Any occurrence of the accident during the execution of above works shall be responsibility of the agency.
6. The agency will ensure refresher training to concerned Medical and Paramedical staffs of the institution for proper segregation of different type of waste with appropriate and up to date training manual.
7. The agency should have a valid authorization certificate from the State/Regional pollution control board for execution of said work or have to obtain the authorization certificate from the State/Regional pollution control board within two months from the date of contract.
8. The agency should have experience in this field for the execution of said work preferably in the Govt. Hospitals.
9. The agency will comply with all the report related to pollution control board as per norms in time.
10. Both the parties will entitle to cancel the agreement with one month prior notice either side in lieu thereof.
11. No advance money will be made to the agency.
12. Transportation of all BMW articles as per BMW rule to the DHH/nearby disposal point with in 48hrs.
13. During the collection and transport of BMW articles the agency has to take all responsibility the proper transportation and disposal of BMW.
14. Reoriented staffs with training /skill to be provided with dress/ Personal Protective Equipments (PPE), etc.
15. Necessary penalty to be imposed to the agency as per TOR detecting any assignment / task.
16. Audit report to be submitted.
17. EMD cost & Rs.30,000/- (Demand Draft) to be deposited in favour of BIO MEDICAL WASTE MANGEMENT (BHAWANIPATNA). This amount will be treated as security deposit for the successful bidders and EMD will be returned to the unsuccessful bidders.
18. Tender paper cost Rs.1000/- (Demand Draft) in favour of BIO MEDICAL WASTE MANGEMENT (BHAWANIPATNA) to be deposited at the time of tender submission which is not refundable.
