



2. Candidates are required to comply with the deficiencies (if any) noted in their respective admit cards on or before 19.10.2019 before the Secretary, DLSA, Kalahandi, Bhawanipatna in order to appear in the written examination.
3. Eligible candidates should reach the venue sharp at reporting time.
4. Candidates appearing 15 minutes after the commencement of the test will not be allowed to appear the test.
5. Any sort of canvassing or attempt to influence the officials related to the selection or the recruitment process would result in immediate disqualification of the candidates. In case of any dispute the decision of the Committee will be final and binding on the candidates.
