Terms & Conditions

Supply of Sports Goods & Equipments for Sports Hostel, Bhawanipatna, Kalahandi

1. The Tenderers must have a valid GSTIN and PAN.
2. Tenderers must have an annual turnover not less than Rs. 10(Ten) lakh in consecutive last two year.
3. Tender paper cost Rs. 500 will be deposited which is non refundable in shape of Demand Draft in favour of Coach Incharge, Sports Hostel, Bhawanipatna payable at SBI, Main Branch, Bhawanipatna, Kalahandi.
4. The Tenderers are required to submit the photocopy of Authorised Dealership Certificate issued by the manufacturers in respect of Branded/standard items as shown in the tender paper.
5. All the documents of quotationers should produce the photo copy of the following documents/papers. If authority desires to know the genuineness of the documents /papers those should be produced in original for confirmation. The quotationers should have been registered under sales Tax Act-1947 Rule-9 &9(A) of the said Act. The sales Tax/GST clearance upto 31.03.2020 obtained from the competent authority should be attached to the Tender Form. The tenderers should furnish copy of Income Tax return for the assessment year 2017-18 & PAN Card along with the Tender Form.
6. The tenderers are required to deposit the EMD amount of Rs. 10000/-(Rupees Ten thousand)only in shape of Demand Draft drawn in favour of Coach In-charge, Sports Hostel, Bhawanipatna along with the tender documents(subject to refund of the same to the unsuccessful tenderer) after selection/finalization by the Tender Committee.
7. The tenderers should produce the sample of 1. Dress materials 2. Shoes materials with socks & 3. Game equipments before the Tender Committee on the day of opening of the Tender.
8. Successful tenderers /suppliers should maintain the branded quality of 1.Dress materials 2.shoes materials with socks & 3. Game equipments while supplying the materials as per the sample approved by the Tender Committee.
9. Performance Security of 5% of the value of Goods quoted is to be submitted by the selected agency in shape of Demand Draft or Bank Guarantee which shall be remain valid for 60 days from date of end of warranty obligation.EMD of the successful bidder shall be returned upon receipt of Performance Security.EMD of unsuccessful bidders shall be returned within 7(seven) days from the date of opening of bid. In absence of any documents as above the Tender paper will be liable for rejection by the Tender Committee.
10. The authority reserves the right to accept or reject any or all the Tenders without assigning any reason thereof.
11. The Tender paper received after due date and time as well as without EMD and other required documents shall not be taken into consideration.
12. Rate quoted should valid up to 31.03.2020.
13. The Sealed Tender paper will be received only through Speed Post/ Registered Post addressed to the District Sports Officer, Collectorate, Kalahandi on or before Dt.13.11.2019 up to 5.30 PM.
14. In case of any complaint regarding the supplied materials the decision of the Chairman Tender Committee-cum-ADM, Kalahandi shall be binding and final. He shall obtain a report from the recipients and then the suppliers shall replace the same at his/her own cost.
15. Purchase order will be placed as per actual requirement to supply within 20 days from the date of order placed, If the supplier failed to supply the materials within the stipulated period and as per the approved samples, the EMD will be forfeited and the purchase order will be cancelled.
16. SPORTS HOSTEL BHAWNIPATNA should be printed on the back side of the upper part of the supplied Track Suit, Banians & Kit Bag.
17. Dispute, if any should be within the jurisdiction of Bhawanipatna only.
