4. **Additional performance security:** As per amendment to Para 3.5.5 (V) of Note-II of OPWD Code, Vol-I by modification vide Works Department, Government of Odisha Office Memorandum No-07556900012013-14299/03.10.2017, Additional Performance Security shall be obtained from the Bidder when the Bid amount is less than estimated cost put to tender. In such an event, only the successful Bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount as Additional Performance Security (APS) in shape of Demand Draft / Term Deposit Receipt pledged in favour of Executive Officer, Notified Area Council, Dharamgarh within seven days, otherwise the bid shall be cancelled and security shall be forfeited. Further, proceeding for black listing shall be initiated against bidder.

6. The bidders must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only in "ON LINE" on or before **5.00 P.M.** on dated **05.12.2019**
8. Bids received ON LINE shall be opened at **11.00 A.M** on dated **07.12.2019** in the Office of the Executive Officer, Notified Area Council Dharamgarh in presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
9. After the date and time of receipt of Bid is over, **the original bid security and Demand draft towards cost of Bid documents shall be submitted in the office of the undersigned in the specified tender box on or before date & time of opening of Bid** as specified at Para 08 above, during office hours on working days failing which the bid will be rejected.


