  - (b) Valid GST Certificates issued from the Competent Authority.
- The firm must have produce sample of the Smokeless Chulla & demonstrate before the quotation committee for selection.
- The material should be delivered at concerned School/Hostel point as per list enclosed and obtained the certificate from the Head Masters / Head Mistress before payment of the bill. The supplier has to demonstrate the cooking procedure to the Cook engaged in the hostels.
