TERMS AND CONDITIONS.

1. Intending bidders have to enclose a demand draft of RS.5,000/- (Rupees Five thousand) only as earnest money drawn in favour of R.T.O, Kalahandi payable at SBI main Branch, Bhawanipatna along with the seal tender, otherwise the tender will not be accepted. The earnest money deposited shall not earn any interest.
2. The tender should be sent in a sealed cover in the address of the Regional Transport Officer, Kalahandi by Speed Post/ Regd Post so as to reach on or before 27.02.2020 by 3.00 P.M and same will be opened on the same day at 4.00 PM by the Tender Committee in presence of the tenderers or their authorized representatives.
3. The upset price of the Jeep is RS.40,000/- (Rupees Forty thousand) only.
4. The Jeep can be Inspected in any working day between 10.00 AM to 4.00 PM in the premises of office garage of R.T.O, Kalahandi.
5. The selected bidder shall have to deposit 25% of the highest bid amount immediately after the announcement and the rest within 07 (Seven) days from the date of auction sale. On failure to make payment within the stipulated period, the aforesaid bid amount along with the earnest money shall be forfeited and the Jeep shall be put to auction afresh or the next higher bidder shall be given preference to take the vehicle.
6. The bidder/ tender whose bid was made absolute shall remove the Jeep from the site within 07 days from the date of depositing the full bid amount. It will be his responsibility to look after the Jeep at his own expenses and the undersigned will no way responsible for any damage to the Jeep.
On failure to remove the Jeep within the stipulated period of Seven days, ground rent as per rule shall be charged till removal of the Jeep from the site.
