**TENDER CALL NOTICE FOR SUPPLY OF DIET**





- ❖ Any deviation from the guidelines will lead to cancellation of contract at any time.
- ❖ Valid, certified and renewed licence for Sale/Storage for Sale/Distribution of food is required to be produced at the time of submitting the bid.
- ❖ No sub-letting of contract or sub-contracting is permissible.




