

The Sealed quotations in plain papers should be submitted by 01.00 PM of 11.06.2020 in the office of the Sub-Collector, Bhawanipatna and the quotation shall be addressed to the Sub-Collector, Bhawanipatna accompany by a Bank draft towards earnest money deposit amounting to Rs. 1,000/- (Rupees one thousand) only drawn in SBI, Main Branch, Bhawanipatna in favour of Sub-Collector, Bhawanipatna payable at SBI, Bhawanipatna which shall be subject to refund immediately except in case of the highest bidder accepted by the Sub-Collector, Bhawanipatna. The quotation will be opened in the office chamber of the Tahasildar, Kalahandi by the Sub-Collector, Bhawanipatna in presence of the Tenderers or their authorized agents on dated, 12.05.2020 at 11.00 AM, so the tenderers are also requested to remain present accordingly.. The highest bidder at or above the minimum price shall be approved by the Sub-Collector, Bhawanipatna then and there. The highest Tenderer shall deposit 25% of the bid amount immediately after announcement and rest within 7 days of the approval of the offer with the Sub-Collector, Bhawanipatna.
2. The bidders will receive the vehicle from the office garage of the Tahasildar, Kalahandi within 7 days from the date of deposit the full amount of the tendered/ negotiated money otherwise the amount deposited shall be forfeited and the bidder will be seized to have any right on the auction sale. Custody or safe guard of the vehicle shall be responsibility of the tenderer/ party and to claim or complaint on that account shall be not admissible.
3. Relevant documents along with the vehicle may be inspected in any working day from 07.00 AM to 01.00 PM on prior appointment with the Tahasildar, Kalahandi.
4. On failure to make payment as aforesaid the deposits (including earnest money) shall be forfeited and the vehicle put to fresh tender as the case may be.
5. The vehicle shall not be delivered to the Tenderers/party until payment and compliance with requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
6. On failure to remove the vehicle within the time as foresaid, ground rent of the rate of one percent of the tendered/ negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.
7. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.






