Sealed Quotation / Tenders are invited from interested Travel Agencies/ Tour Operators for providing One Number of Tiago/ Bolt /Celerio (Petrol) driven vehicle with sitting capacity not more than 05 including driver on hiring which shall confirm to following terms and conditions.

1. Vehicle will be used in D.R.C.S., Kalahandi Division, Bhawanipatna on monthly rent basis for Official use.

The vehicle must be inroad worthy condition and shall not be more than 03 (three) years old from the date of initial registration and must be have valid contract carriage permit, up-to-date Tax payment GST registration and GeM registration are compulsory for any service provider to provide hired vehicle to Govt. Office through GeM or through open bidding etc. which are mandatory for plying of vehicle.

2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.

3. The Driver should be well behaved, gentle and obedient in nature.

4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of A/C Payee Bank Draft in favour of the Deputy Registrar of Cooperative Societies, Kalahandi Division, Bhawanipatna and submit along with the tender as security deposit. After completion of Tender the amount will be refunded to unsuccessful bidders.

5. The monthly rate of hire charges be quoted separately in general bid information (excluding fuel and lubricant).

6. The vehicle must achieve fuel efficiency of 17 K.M. per liter.

7. Details of the make and year of the manufacture of the vehicle, Registration number, Mileage (K.M, covered per Litre) and name of the Driver with driving license number and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Ann.III).


