## SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

1. The Project Administrator, ITDA, Th. Rampur at Bhawanipatna required the services of reputed, well established and financially sound Manpower Service Providers to provide services of Technical Consultant on contract basis for day to day official work.
2. The contract for providing the aforesaid manpower is likely to commence after selection of the service provider by the selection committee and would ordinarily continue for a period of one calendar year from the date of execution of agreement. The period of the contract of Service provider Firm may be extended beyond expire of the engagement period, provided the requirement of ITDA, Th. Rampur at Bhawanipatna for manpower persists at the time or may be curtailed / terminated before the engagement period owing to deficiency in service or substandard quality of Manpower deployed by the selected Service Provider or because of change in the requirement of ITDA, Th. Rampur at Bhawanipatna. The ITDA, Th. Rampur at Bhawanipatna, however, reserves right to terminate this initial contract at any time after giving 25 days notice to the selected Service Provider.
3. This ITDA, Th. Rampur at Bhawanipatna has tentative requirement for 01 no. Of Technical person. The requirements may increase.
4. The estimated cost of the contract is Rs. 2,02,560/-.

7. Any tender documents received after due date will be out rightly rejected. ITDA, Th. Rampur will not be responsible for any postal delay.

9. The tender has been invited under **two bid system i.e. Technical Bid and Financial Bid**. The interested agencies are advised to submit two separate sealed envelopes super scribing "**Technical Bid for providing Manpower Services to Project Administrator, ITDA, Th. Rampur at Bhawanipatna and Financial Bid for providing Manpower Services to Project Administrator, ITDA, Th. Rampur at Bhawanipatna**". Both sealed envelopes should be kept in a third sealed envelope superscribing "**Tender for Providing Manpower Services to Project Administrator, ITDA, Th. Rampur at Bhawanipatna**".
10. The Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees Ten Thousand) only refundable (Without interest) should be necessarily accompanied with the technical Bid of the Service Provider in the form of Demand Draft / Pay Order drawn in favour of Project Administrator, ITDA, Th. Rampur at Bhawanipatna **failing which the tender shall be rejected summarily**. The EMD exempted for the MSME agencies.
11. The successful tenderer will have to deposit a Performance Security Deposit of Rs. 20,000/- (Rupees Twenty Thousand) in the form of Fixed Deposit Receipt (FDR) / Bank Guarantee from any Nationalized Bank pledged in favour of Project Administrator, ITDA, Th. Rampur at Bhawanipatna covering the period of contract at the time of signing of the agreement. In case, the contract is further extended beyond the initial period, the FDR / Bank Guarantee will have to be renewed accordingly by the successful tenderer.

**13. *The conditional bids shall not be considered and will be out rightly rejected in very first instance.***

14. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or correction is permitted in the Financial Bid Form. In such cases, the tender shall be liable for rejection. However, the cuttings, if any ; in the Technical Bid Application must be initialled by the person authorized to sign the tender bids.

15. The Technical bids shall be opened on the scheduled date and time at 11.00 AM of 09.07.2021 on (date) in the Project Administrator, ITDA Conference Hall in presence of the representatives of the Manpower Service Providers, if any who wish to be present on the spot at that time.

16. The Financial Bid of only those renderers will be opened whose Technical bids are found in order. The Financial bids shall be opened at 4.00 PM on 09.07.2021 in the office chamber of Project Administrator, ITDA, Th. Rampur at Bhawanipatna in the presence of the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at that time.

17. The Competent Authority of the Project Administrator, ITDA, Th. Rampur at Bhawanipatna reserves the right to annul all bids without assigning any reason.

**TECHNICAL REQUIREMENTS FOR THE TENDERING MANPOWER  
SERVICE PROVIDER**

1. The tendering manpower service provider should fulfil the following technical specifications:
2. The registered office or one of the branch offices of the manpower service provider should be located within the jurisdiction of the Kalahandi District. Proof of documents in support of functioning of Local Branch Office should be attached.
  - a. Besides, if the ITDA / Head of ITDA / Controlling Officer are procuring manpower for deployment in their Field Office (s), the manpower service provider should provide the name, designation and contact number of the person to liaise with the said Filed Office (s).
  - b. They should be registered with the appropriate registration authority.
  - c. They should have at least three years experience in providing manpower to Government Departments / Public Sector Companies / Banks etc.
  - d. They should have their own Bank Account.
  - e. They should be registered with Income Tax and Service Tax Department.
  - f. They should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance Acts.
  - g. The average annual turn-over of the company shall at least be 50 lakhs per annum.
  - h. The agency must have executed contracts of similar type during preceding 3 years of value equal or more than 60% of the estimated cost of the present contract.
  - i. The Agency should fulfil all the statutory compliance of Finance Department, Government of Odisha as stipulated from time to time. The rate quoted by the firm should be adequate enough to cover all the statutory dues of Government. Any firm quoting nil or abnormally low service charges (less than a whole number), unless otherwise allowed to, will be rejected.
  - j. The selected firm is liable to comply with all the terms and conditions stipulated by Government from time to time during the agreement in force.
  - k. In case more than one bidder quote(s) the same price, draw of lottery to nominate the L1 bidder shall be adhered to.
  - l. The sealed tender shall be of two bids system i.e. Technical Bid and Financial Bid. The interested agencies are advised to submit two separate sealed envelopes super scribing.   - m. The Block listed Firm(s) shall outrightly be rejected. An undertaking by bidder should be furnished that, their firm(s) have never been blacklisted in any district.

### **Notes:**

1. The total rates quoted by the tendering agency should be inclusive of all statutory / taxation liabilities in force at the time of entering into the contract.
2. The payment shall be made on conclusion of the calendar month only on the basis of no. Of working days for which duly has been performed by each manpower.
3. The nominated firm shall produce EPF/ESI statement towards testimony regarding deposit of EPF/ESI of staff every month only after which bill for the succeeding month shall be processed.



## TERMS & CONDITIONS

### GENERAL

1. The Agreement shall commence from ..... and shall continue till ..... (One year) unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirements.
2. The Agreement shall automatically expire on dated ..... unless extended further by the mutual consent of the Manpower Service Provider and the Authority.
3. The Agreement may be extended, on the same terms and conditions or with some additions / deletions / modifications for a further specific period mutually agreed upon by the Manpower's Service Provider and the Authority.
4. The Manpower Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and Abilities under this Agreement to any other agency or organization by whatever name be called without the prior written consent of the Authority.
5. The PA, ITDA, Th. Rampur at Bhawanipatna at present has tentative requirement of 01 no. Of Technical Consultant on urgent basis. During the period of initial contract also and the tenderer would have to provide additional manpower services, if required on the same terms and conditions.
6. The Manpower Service Provider will be bound by the terms & condition as furnished by it to the Authority while submitting the tender or at subsequent stage. In case any of such documents furnished by it is found to be false at any stage, it would be deemed to be a breach of terms of Agreement making it liable for legal action besides termination of the Agreement.
7. The Authority reserves the right to terminate the Agreement during initial period also after giving 15 days notice to the Manpower Service Provider.
8. The manpower service will have to deploy manpower within seven days of signing the agreement.
9. The persons deployed shall be required to report for work at 10.00 AM to the PA, ITDA or such other Officer as may have been kept in charge of the Office Establishment of the Office concerned and would leave at 5.30 PM for which he would not be paid any extra remuneration. In case, the person deployed remains absent on a particular day or comes late / leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.

10. The Manpower Service Provider shall nominate a coordinator who shall be responsible for immediate interaction with ITDA, Th. Rampur at Bhawanipatna so that optimal services of the persons deployed could be availed without any disruption.
11. The entire financial liability in respect of Manpower Services deployed in ITDA shall be that of the Manpower Service Provider and ITDA, Th. Rampur at Bhawanipatna will in no way be liable for any lapses. It will be the responsibility of the Manpower Service provide to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidence as may be required by ITDA, Th. Rampur at Bhawanipatna for reimbursement of Bill of the firm for the succeeding month. If at any point of time it is noticed that the agency paying lesser remuneration to the candidates that the rate quoted, than the agreement shall be terminated and EMD & Security etc deposits shall be forfeited forthwith.
12. The payment of remuneration to the manpower has to be through bank account only. No cash payment can be made to them.
13. For all intents and purposes, the Manpower Service Provider shall be the "Employer" within the meaning of different Rules & Acts in respect of Manpower to deployed. The persona deployed by the Manpower Service Provider shall not have any claim whatsoever like employer relationship against ITDA, Th. Rampur at Bhawanipatna.
14. The Manpower Service Provider shall be solely responsible for the redressal of grievances or resolution of disputes relating to persons deployed. ITDA, Th. Rampur at Bhawanipatna shall in no way be responsible for settlement of such issues whatsoever. In case the grievances of the deployed person are not attended to by the Manpower Service Provider the deployed person can place their grievance before a Joint Committee consisting of a representative of ITDA, Th. Rampur at Bhawanipatna and an Authorized representative of the Manpower Service Provider.
15. ITDA, Th. Rampur at Bhawanipatna shall not be responsible for any financial loss or any injury to any person deployed by the Manpower Service Provider in the course of their performing the functions / duties or for payment towards any compensation.
16. The persons deployed by the Manpower Service Provider shall not claim nor shall be entitled to pay, parks and other facilities admissible to regular / confirmed employees during the currency or after expiry of the Agreement.
17. In case of termination of this Agreement on its expire or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.



18. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with officio under the provision of rules and Acts. Undertaking from the person deployed to this effect shall be required to be submitted by the Manpower Service Provider.
19. The Manpower Service Provider must be registered with the concerned Govt. Authorities. i.e. Labour Commissioner, Provident Fund Authorities, Employees State Insurance Corporation etc and a copy of the registration should be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining License under Contract Labour (Regulations and Abolition) Act, 1970 if any, at his own part and cost.
20. The Manpower Service Provider shall provide a substitute well in advance, if there occurs any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the Manpower Service Provider. The Manpower Service Provider shall be responsible for contributions towards Provident fund and Employees State Insurance, wherever applicable.
21. The person deployed by the Manpower Service Provider should have good police records and no criminal case should be pending against them.
22. The persons deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of ITDA, Th. Rampur at Bhawanipatna. The Manpower Service Provider shall be responsible for any act of indiscipline on the part of the persons deployed.

### LEGAL

23. The persons deployed shall during the course of their work be privy to certain qualified Documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take oath of confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person deployed liable for penal action under the applicable laws besides, action for breach of contract.
24. The Manpower Service Provider shall be responsible for compliance of all statutory provisions relating to minimum wages payable to different types of worker in respect of the persons deployed by it in ITDA, Th. Rampur at Bhawanipatna. The ITDA, Th. Rampur at Bhawanipatna shall have no liability in this regard.
25. The Manpower Service Provider shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the ITDA, Th. Rampur at Bhawanipatna to the concerned tax collection authorities from time to time as per the rules and regulations in



the matter. Attested Xerox copies of such documents shall be furnished to ITDA, Th. Rampur at Bhawanipatna.

26. The Manpower Service Provider shall maintain all statutory registers under the Law and shall produce the same on demand to the ITDA, Th. Rampur at Bhawanipatna or any other authority under Law.
27. The Tax deduction at source (T.D.S.) shall be done as per the provisions of Income Tax Act / Rules, as amended from time to time and a certificate to this effect shall be provided by ITDA, Th. Rampur at Bhawanipatna.
28. In case, the Manpower Service Provider fails to comply with any liability under appropriate law and as a result thereof ITDA, Th. Rampur at Bhawanipatna is put to any loss / obligation, monetary or otherwise ITDA, Th. Rampur at Bhawanipatna will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Manpower Service Provider to the extent of the loss or obligation in monetary terms.
29. The Agreement is liable to be terminated because of non-performance, deviation of terms and conditions of contract, non-payment of remuneration of employed person and non-payment of statutory dues. The ITDA, Th. Rampur at Bhawanipatna will have no liability towards non-payment of remuneration to the persons employed by the Manpower Service Provider and the outstanding statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the ITDA, Th. Rampur at Bhawanipatna by the persons deployed the same shall be recovered from the unpaid bills or adjusted from the Performance Security Deposit.

## **FINANCIAL**

30. The Technical Bid should be accompanied with an Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees Ten Thousand only) refundable without interest in the form of Fixed Deposit Receipt (FDR) pledged in favour of Project Administrator, ITDA, Th. Rampur at Bhawanipatna failing which the tender shall be rejected out rightly.
31. The Earnest Money Deposit in respect of the agencies which do not qualify the Technical Bid (First Stage) / Financial Bid (Second competitive stage) shall be returned to them without any interest. In case of successful tenderer if the agency fails to deploy the required manpower against the initial requirement within 30 days from date of placing the order the EMD shall stand forfeited without giving any further notice.
32. The successful tender will have to deposit a Performance Security Deposit of Rs. 20,000/- in the form of Fixed Deposit Receipt (FDR) / Bank Guarantee from any Nationalized Bank pledged in favour of Project Administrator, ITDA, Th. Rampur at

Bhawanipatna covering the period of contract at the time of signing of the agreement. In case, the contract is further extended beyond the initial period, the FDR / Bank Guarantee will have to renewed accordingly by the successful tenderer.

33. In case of breach of any terms and condition attached to this agreement the performance Security Deposit of the Manpower Service provider shall be liable to be forfeited besides annulment of the Agreement.
34. The Manpower Service Provider shall raise the bill in triplicate alongwith attendance sheet duly verified by the ITDA, Th. Rampur at Bhawanipatna in respect of the persons deployed and submit the same to the prescribed authority in the first week of the succeeding month. As far as possible the payment will be released by the second week of the succeeding month.
35. The claims in bills regarding Employees State Insurance, Provident Fund and Service Tax etc should be necessarily accompanied with documentary proof pertaining to the concerned bill month. A requisite portion of the bill or whole of the bill amount shall be held up till such proof is furnished at the discretion of the ITDA, Th. Rampur at Bhawanipatna.
36. The amount of penalty calculated @ Rs. 100/- per day account of delay if any in providing a suitable substitute for the period beyond three working days by the Manpower Service Provider shall be deducted from its monthly bills in the succeeding month.
37. The Authority reserves the right to withdraw or relax any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage.
38. In the event of any dispute arising in respect of the clauses of the agreement the same shall be resolved through negotiation. Alternatively the dispute shall be referred to the next higher authority or controlling officer for his decision and the same shall be binding on all parities.
39. All disputes shall be under the jurisdiction of the District Civil Court located at Kalahandi in the District of Kalahandi.
40. The successful bidder will enter into an agreement with the ITDA, Th. Rampur at Bhawanipatna for supply of suitable and qualified manpower as per requirement of this ITDA, Th. Rampur at Bhawanipatna on the above terms and conditions.
