Where as in response to the Advertisement No. 1636/ DRDA dtd 23.03.2021 of the DRDA, Kalahandi, Bhawanipatna for recruitment to fill up 66 (sixty six) numbers of Gram Rozgar Sevak (GRS) under MGNREGS in total 2731 numbers of applications have been received at DRDA Office, Kalahandi. The selection committee verified the applications, and prepared the list of eligible candidates as per the criteria reflecting the ground of ineligibility of the candidates.
