

Whereas in response to the Corrigendum No. 6734 dtd.22.12.2021 to the Advertisement No. 1636/ DRDA dtd.23.3.2021 issued by the DRDA, Kalahandi, Bhawanipatna for recruitment to fill up 66 (sixty six) numbers of vacant posts of Gram Rozgar Sevak (GRS) under MGNREGS, in total 796 numbers of applications have been received at DRDA Office, Kalahandi. Further, 138 (one hundred thirty eight) numbers of Applications, lately received in the 1st phase, have been carried forward, and included in the list. And 04 (Four) numbers of applications, which were found to be none GRS, and duplicate applications were not taken into consideration. Hence, the total number of applications for the post of GRS comes to 930. The selection committee has verified the applications, and prepared the list of eligible and ineligible candidates as per the criteria reflecting the ground of ineligibility of the candidates. On scrutiny, the status of the applications received is as follows:-
